#### 1. Discussion and Possible Action to Approve Minutes

## 2. <u>Discussion and Possible Action to Approve the Consent Agenda for Travel Vouchers Currently Outstanding</u>

Title 85A O.S. § 23 states, [a]ny Commissioner or employee of the Commission shall be entitled to receive his or her necessary traveling expenses as provided in the State Travel Reimbursement Act. The expenses shall be certified by the person who incurred them and shall be allowed and paid on presentation of vouchers approved by the Commission." In accordance with this section, the Commission will consider a vote to approve the currently outstanding vouchers.

All travel vouchers listed within this Consent Agenda have been made available to each Commissioner prior to today's meeting, are considered routine, and will be enacted by one motion of the Commission. If separate discussion is desired, that item may be removed from the Consent Agenda and voted upon separately.

## 3. Request to Reduce Security Deposit for International Paper Co., Former Own Risk Permit #14354

International Paper Co. ("the Company"), former own risk permit #14354, was a self-insured employer in the Own Risk program until January 1, 2017. The Company has petitioned the Commission to reduce the Company's security deposit on file. The Commission currently holds

a \$2,100,000 Surety Bond, as security deposit. They are requesting a reduction of their security deposit to \$800,000. The outstanding claims have a total balance of \$700,726.

The Company has complied with Commission Rule 810:25-9-19.

## 4. <u>Discussion and Possible Approval of Contract for Spring Semester Interns from the Cristo</u> Rey Work Study Program ("CWSP")

The Commission will discuss and consider approval of the CWSP contract to hire one student team of four students for the spring 2023 semester in the amount of \$17,000.

The Commission will discuss and consider approval of its FY2024 operating budget, as proposed.

# 6. <u>Proposed Opening of the Permanent Rulemaking Process to Consider Amendments to the Commission's Permanent Rules</u>

The Commission will consider opening the rulemaking process for amendments to the Commission's Permanent Rules. If proposed Permanent Rules are adopted and submitted for legislative review on or before April 1, 2023, the Legislature will have until the end of the 2023 legislative session to approve or disapprove the rules.
