

Weekly Death Benefits for Deaths Occurring During the Period of November 1, 2016 Through October 31, 2017- 85A O.S. §47(C) ¹

The following chart represents the aggregate weekly income benefits payable to all beneficiaries of a deceased worker whose AWW equals or exceeds the SAWW of \$851.47

Beneficiary or Beneficiaries	Calculation	Benefit Amount for Beneficiary	Aggregate Benefit Amount Per Week For All Beneficiaries
1. Spouse only:	$\$851.47 \times 70\%$	\$596.03	\$596.03
2. Spouse and one (1) child	Spouse: $\$851.47 \times 70\%$ Child: $\$851.47 \times 15\%$	\$596.03 \$127.72	\$723.75
3. Spouse and two (2) or more children	Spouse: $\$851.47 \times 70\%$ Children: $(\$851.47 \times 30\%) \div$ (# of children) = benefit per child	\$596.03	\$851.47
4. No spouse, one (1) child	$\$851.47 \times 50\%$	\$425.74	\$425.74
5. No spouse, two (2) children	Child #1: $\$851.47 \times 50\%$ Child #2: $\$851.47 \times 50\%$	\$425.74 \$425.74	\$851.47
6. No spouse, three (3) or more children	$\$851.47 \div$ (number of children) = benefit per child	Variable	\$851.47
7. No spouse or children, actually dependent beneficiary	$\$851.47 \times 25\%$ = benefit per beneficiary	\$212.87	
8. Alien nonresident dependents in any foreign country		See 85A O.S., §11	

¹Weekly death benefits are computed as percentages of the average weekly wage of the deceased worker, **not to exceed the state's average weekly wage. This chart is only a guide and benefit amounts may vary** based upon the average weekly wage of the deceased.

Lump Sum Death Benefits—85A O.S. §47(C) ¹

1. Spouse Only	Spouse: \$100,000; Funeral expenses: maximum of \$10,000
2. Spouse and one (1) child	Spouse: \$100,000; Child; \$25,000 ; Funeral Expenses: maximum of \$10,000
3. Spouse and two (2) or more children	Spouse: \$100,000; Children: \$50,000 divided equally; Funeral expenses: maximum of \$10,000
4. No spouse, up to two (2) children	Children: \$25,000 per child; Funeral expenses: maximum of \$10,000
5. No spouse, more than (2) children	Children: \$25,000 per child, up to a maximum of \$150,000 divided equally; Funeral Expenses, maximum of \$10,000
6. Spouse, upon remarriage	Two (2) years' indemnity benefit in one lump sum

¹All benefits awarded to a child are payable to the legal guardian of the estate of the minor at the Commission's discretion.
