- ___ 6. Application Page 10A or 10B. Corporations only must complete 10A. Limited Liability Companies must complete 10B.
- ___ 7. Oklahoma Price Posting Affidavit. Applicant must read, complete and sign the form before a notary public. If applicant is a corporation, a corporate officer must sign.
- ___ 8. Price Posting Forms.
 - a. Short Form Price Registration by Non-Resident Seller.
 - b. Oklahoma Price Posting Form.
 - c. Short Form Price Registration for Strong Beer.
 - d. Oklahoma Strong Beer Price Posting.
- ___ 9. Label Registration Form.

II. Documentation Supplied by Applicant.

- ___ 1. Certificate of Authority or Registration. Certificate is obtained from the Oklahoma Secretary of State, 101 State capitol Building, Oklahoma city, OK 73105; Telephone number (405) 521-3911. Applicant must contact the Secretary of State directly to obtain the forms necessary to apply for a Certificate of Authority for corporations or Certificate of Registration for limited liability companies.
- ___ 2. Letter of Conformity. A letter from the applicant, signed before a Notary Public stating that the company will sell their products to all Oklahoma licensed wholesalers without discrimination.
- ___ 3. Labels. Front and back labels of each product to be marketed in Oklahoma. Prior approval must be obtained from the Oklahoma Tax Commission, Business Tax. Division, Attn: Randy Ross, 2501 N. Lincoln Blvd., Oklahoma City, OK 73194-0004; telephone number (405) 521-4557 on all beer labels. Approval from the Tax Commission must be submitted along with the brand registration fee for each beer to be registered in this state for sale.
- ___ 4. Federal Label Approval.
- ___ 5. Photographs. All 8" x 10" photograph of each decanter that will be marketed in Oklahoma.
- ___ 6. Fees.
 - a. Brand Registration Fee. Annual fee for each brand of spirits is three hundred seventy five dollars (\$375.00) and for each brand of wine and beer two hundred dollars (\$200.00). A fee schedule is enclosed. If the application for a brand label is denied the registration fee less twenty-five per cent (25%) will be returned. Enclose a cashier's check, money order or business check in the correct amount made payable to ABLE Commission.
 - b. License Fee. The fee is prorated from the nearest first of the month through June 30th at a rate of sixty-two dollars and fifty cents (\$62.50) per month. A fee list is enclosed. Enclose a cashier's check, money order or business check in the correct amount made payable to ABLE Commission.
- ___ 7. Copies. Mail original application and supporting documents with one (1) copy to: Oklahoma ABLE Commission, 3812 N. Santa Fe, Suite 200 Oklahoma City, Oklahoma 73118. **Walk-in applications are accepted 7:30 a.m. to 4:00 p.m. Monday - Friday.**

NONRESIDENT SELLER FEE LIST

A nonresident seller (NRS) license is \$750.00 per year (July 1-June 30th) and runs concurrently with annual brand registration. When application is made for a new or an initial NRS license after July 1 of any year, the license fee will be prorated through the following June 30th on a quarterly basis. Along with the license fee, a surcharge of \$2,500 is required. Listed below are the fee and surcharge that will be assessed for a new or an initial NRS license when application is made during any of the following quarters.

The annual renewal fee and surcharge for a NRS license, regardless of when the initial application was made, is \$750 plus \$2,500.

BRAND REGISTRATION FEE LIST

All products must be registered prior to sale in the State of Oklahoma. A copy of the COLA, a set of actual labels and if the nonresident is not the brand owner and appointment letter must be included. The brand registration fee for liquor is \$375.00; for beer \$200.00; and \$200 for wines per year (July 1 – June 30) and runs concurrently with the NRS license. Brand registration fees for new labels registered after the First Quarter may be prorated on a quarterly basis. For example, a new label posted by August 15th with an effective registration date of October 1st will only pay three-fourth's (3/4) of the annual brand registration fee for that year.

The following prorated brand registration fees are listed below and shall be assessed for the following quarters:

Spirits (\$375)

A separate fee for each brand of spirits that differs as to name, class, type, age or proof. Items that differ only as to color or flavor may be considered one (Example: Light and Dark Rum = one fee).

Cordials & Specialties (\$375)

A separate fee for each brand of cordials and specialties will be required. If items of the brand vary only as to flavor they may be considered one. A separate fee shall be required for cordials in the following categories: Specialties and flavored brandies.

Domestic Wines (\$200)

A separate fee for each brand label in the following categories:

1. Fortified (over 14%)
2. Specialties
3. Table or light wines
4. Sparkling (champagnes, artificially carbonated wines)

Imported Wines (\$200)

A separate fee shall be required for each imported or foreign wine with the same country of origin within the following classes or types:

1. Red (under 14%)
2. White (under 14%)
3. Rose (under 14%)
4. Fortified (over 14%)
5. Sparkling
6. Specialties

Beer (\$200)

A separate fee for each brand of beer will be required. Example St. Pauli Light & St. Pauli Dark = 2 separates.

Beer manufactured in this state shall be exempt from brand registration fees.
