## 3. Comments received

390:15-1-9. Council Instructions - Agent Gooch stated his concern for the proposed change in (c) Basic Academy skills instructors complete a minimum of 20 hours of CLEET-catalogued continuing education related to their instructorship specialty every three years. Lead instructors will not be adequately trained. Agent Gooch stated that he felt this was not sufficient.

390:20-1-3. Reserve peace officer certification training.

Similar proposed changes were published for rule 390:10-1-6 with regard to fulltime peace officer reciprocity. During the comment period, it was discovered that this rule should be amended so that the rules for fulltime and reserve officers would be consistent.

390:35-15-1. Private security school accreditation.

390:60-13.1. Private school accreditation.

The published proposed rule changes did not account for the fact that Phase 4 has options for shotgun and rifle training in addition to handgun. This update recognizes those options and provides a mechanism for potentially teaching combined courses upon specific course approval.
