10. **Bomb Dog Advisory Committee will have open discussion whether to accept AK9I Handler School in Virginia as a certifier for Oklahoma Bomb Dogs. Larry Watson will discuss his points. This was tabled by the BDAC from the September meeting.**

**Discussion:** Larry Watson, a licensed Private Investigator in Oklahoma; attended the meeting to share his training with AK9I. He asked the council to accept his training to be an Oklahoma bomb dog handler. Each of the board members asked Mr. Watson questions about his training and why he didn't seek out already approved training in the State of Oklahoma. The board expressed concern with a conflict of interest of him certifying his dog from the same place he purchased. Mr. Watson said he didn't realize there were any guidelines for training or schools in Oklahoma. Chairman Carrillo stated he will reject his request due to the conflict of interest and the liability of not being associated with a bomb squad. Chairman Carrillo did offer his personal assistance and the assistance of his agency in helping Mr. Watson obtain his K9 training in the State of Oklahoma through previously approved resources.

**Action Taken:** Lt. Carrillo made a motion to reject Mr. Watson's motion to have AK9I as an approved certifier for Oklahoma Bomb Dogs. MSgt. Spillman seconded the motion. Lt. Carrillo voted yes. MSgt. Spillman voted yes. Officer Trice voted yes. MSgt. Vollmer voted yes. Motion carried 4-0.
