6. Pending changes to Oklahoma Drug Dog Standards and Guidelines.

- 2.5 Every new drug detection dog handler should go through a basic handler school <u>no less than</u> <u>four weeks</u>. It is recommended the course be accredited by CLEET. This course should be completed prior to attempting to certify as canine team with the State of Oklahoma. <u>The course</u> is meant for beginner (green) handlers and beginner (green) canines.
- 2.7 If a handler has certified with previous narcotic canines, a two-week course shall suffice.
- 2.8 <u>The guidelines in 2.5 will not affect continuing education courses, seminars, or conferences.</u>
