Dr. Wayne Scott Harrington's license revocation hearing has been set before the Board of Dentistry on August 16, 2013, a regularly scheduled Board meeting.

Dr. Harrington voluntarily agreed to suspend his license pending a hearing on the temporary suspension within 30 days as required by law. Dr. Harrington has waived his right to a hearing on the temporary suspension. As a result, the hearing set for April 19, 2013 has been cancelled.

By agreement of the parties a full hearing to consider the revocation of his license has been set for August 16, 2013, a regularly scheduled meeting at the State Board of Dentistry at 201 NE 38<sup>th</sup> Terrace, Suite 2, Oklahoma City, OK 73105. ## AGREED ORDER FOR TEMPORARY SUSPENSION

- 1. The Board of Dentistry ("Board") has jurisdiction over the practice of dentistry, individuals licensed to practice dentistry in the State of Oklahoma and this proceeding pursuant to the State Dental Act ("Act"), Title 59 O.S., § 328.1 et. seq., and its predecessor statutes.
- 2. WAYNE SCOTT HARRINGTON, D.M.D. license # 3666, issued June 23, 1974 and and Oral Surgery Specialty license # 59, issued June 10 1977, is licensed to practice dentistry in the State of Oklahoma.
- 3. In lieu of an emergency hearing, Dr. Harrington voluntarily surrendered his license pending an emergency hearing of suspension on March 20, 2013. A hearing on the temporary suspension has been set for April 19, 2013 at the State Board of Dentistry Office, 201 NE 38<sup>th</sup> Terrace, Suite 2, Oklahoma City, Oklahoma within 30 days as required by law.
- 4. By agreement of the parties, Dr. Harrington, by and through his attorney James Secrest II, waives his right to a hearing on the temporary suspension.
- 5. The temporary suspension shall remain in full force pending a full and final hearing set for August 16, 2013 at a regularly scheduled meeting of the Board of Dentistry at 201 NE 38<sup>th</sup> Terrace, Suite 2. Oklahoma City, Oklahoma at 9:00 a.m.
