 - g. Past and proposed legislation affecting dentistry, federal and state;
 - h. Shortages of hygienists and dental assistants and advanced procedure/expanded function training for both;'
 - i. Additional/new procedures for hygienists and dental assistants in nursing homes and other settings;
 - j. Unnecessary and outdated language in the statutes and rules;

Input and discussion is encouraged from licensees and interested parties during this training. NO VOTES WILL BE TAKEN DURING THE TRAINING AND REVIEW portion of the meeting; A summary of the discussion will be available in the minutes to be approved at the November meeting.
