STATE CAMPAIGN REPORTING DATES

All Committees Supporting or Opposing State Candidates in the 2008 Elections [does not apply to 2008 special election candidates who filed declarations of candidacy prior to June 2, 3 & 4]

SO-1 Due [CC-2008 only]	no later than 10 days after committee accepts or expends in excess of \$500 or June 16, 2008, whichever is earlier
SO-2 Due [NC’s only]	no later than 5 days after the committee accepts or expends in excess of \$500 and by January 31, 2008
Notice of vacancy in committee office	within 5 days after a vacancy occurs in a committee office other than deputy treasurer
Other amendments to SO-2	within 10 days of change
