State Campaign Reporting Dates

All Committees Supporting or Opposing State Candidates in the 2010 Elections [does not apply to 2010 special election candidates who filed declarations of candidacy prior to June 7, 8 & 9]

SO-1 Due [CC-2010 only].	no later than 10 days after committee accepts or expends in excess of \$500 or June 21, 2010, whichever is earlier
SO-2 Due [NC’s only].	no later than 5 days after the committee accepts or expends in excess of \$500 and by February 1, 2010
Notice of vacancy in committee office	within 5 days after a vacancy occurs in a committee office other than deputy treasurer
Other amendments to SO-2.	within 10 days of change
