State Campaign Reporting Dates

All Committees Supporting or Opposing State Candidates in the 2012 Elections [does not apply to 2012 special election candidates who filed declarations of candidacy prior to April 11, 12 & 13, 2012]

SO-1 [CC-2012 only] Due.....	no later than 10 days after committee accepts or expends in excess of \$500 or April 23, 2012, whichever is earlier
SO-2 [NC' s only] Due.	no later than 5 days after the committee accepts or expends in excess of \$500 and by January 31, 2012
Notice of vacancy in committee office - Due	within 5 days after a vacancy occurs in a committee office other than deputy treasurer
Other amendments to SO-2 Due.	within 10 days of change
