#### MINUTES OF A MEETING OF THE OKLAHOMA MOTOR VEHICLE COMMISSION

In conformity with the Oklahoma Open Meeting Act, advance notice of this regularly scheduled meeting was transmitted to the Oklahoma Secretary of State on October 14, 2009 and public notice of this meeting, together with the agenda, was posted in prominent public view on the front door of the Northwest Office Center, 4334 NW Expressway, Oklahoma City, on July 12, 2010 at 10:00am. The announcement of the Board meeting and agenda were also posted on the OMVC website <u>www.ok.gov/omvc</u> on July 12, 2010 at 10:00am.

The Oklahoma Motor Vehicle Commission met in a regular session at 10:00 a.m. July 13, 2010 in the Conference Room of the Northwest Office Center, 4334 N.W. Expressway in Oklahoma City. Chairman Greg Cable called the meeting to order. A roll call was held; members present were Bruce Barber, Greg Cable, Carol Carver, Gene Chumbley, Randy Coy, David Howe, Steve Kissee, Dick Reynolds, and Eric Stuteville.

The Chairman announced that there were enough members present to constitute a quorum. Also present were Roy Dockum, Executive Director, Marilyn Maxwell, Deputy Director, and Sandra Balzer, Assistant Attorney General.

#### Presentation by Sandra Balzer, Assistant Attorney General

Ms. Balzer gave a PowerPoint presentation which focus on the responsibilities of the OMVC under the Oklahoma Open Meeting and Open Records Act.

### **Director's Report:**

The Director reported that the license renewal process was about 90% completed. Preliminary numbers indicate that the number of licenses will be down between 12% and 15% from the previous year. The loss of dealer franchise licensees is largely due to reductions in the following areas: elimination of vehicle makes such as Pontiac, Saturn, Hummer; termination of certain GM and Chrysler dealerships due to the manufacturers' bankruptcies in 2009; the closing of many electric car dealerships and scooter dealerships; and reduction of several RV franchises offered by dealers. He also reported that preliminary revenue projections indicate that the FY2011 income may be about \$35,000 higher than originally estimated in the proposed budget presented at the June 2010 OMVC meeting. Final license renewal figures will be presented at the August 10, 2010 meeting of the Board.
