**<u>DIRECTIONS</u>**: From I-44 and N. May Ave. take the I44 service road (also known as NW 39<sup>th</sup> Street) West. Then turn left onto N. Drexel Blvd. Then take the 1<sup>st</sup> right onto NW 39<sup>th</sup> Street.

**PROPERTY CONDITION:** The subject property is located on a 3.52 acre site at the southeast corner of I-44 and Hefner Parkway junction. The improvements consist of two motel properties built in the mid-century. The east component is an older motel with approximately 11,137 GSF that is in poor condition. The newer of the two is a two-story motor court motel with approximately 25,712 GSF that is in fair condition, with some portions in poor conditions. The existing improvements were determined not to contribute any value to the site. The value of the property is solely in its underlying land value (per appraiser). PROPERTY SELLS "AS IS, WHERE IS". The appraised value of \$780,000 represents the value of the LAND only and does not include the buildings, any improvements or demolishing.
