Mr. George Tarlas briefly reviewed with the Board the Quarterly Report for the quarter ended September 30, 2010, a copy of which is attached as Exhibit "E." **DISCUSSION OF POSSIBLE AMENDMENTS TO THE ADMINISTRATIVE RULES PROMULGATED BY THE OKLAHOMA POLICE PENSION AND RETIREMENT BOARD. AREAS TO BE DISCUSSED MAY INCLUDE, BUT ARE NOT LIMITED TO, THE FOLLOWING: CLARIFICATION OF NEW CITY MEMBERSHIP AND COMMON LAW MARRIAGE AS IT RELATES TO BENEFICIARY RIGHTS.**

One rule change clarifies the effective date a new municipality joins the System. The city becomes a member city the first day of the following month after Board approval.

A new rule will be added which sets out the basis in which a common law spouse may receive beneficiary rights.

Language for these rule amendments will be approved in the next Board meeting.
