Teleconference Board Meeting Conduct Rules

This is a reminder that all meetings of the Oklahoma Board of Chiropractic Examiners are open to the general public.

During the meeting it will be important that background noise be eliminated in order for all those attending the teleconference can hear clearly. All phones should be muted during discussions.

Only those agenda items on the agenda can be addressed during the meeting.

The Board is not required to receive public comment during a meeting. Whether to allow public comment is in the discretion of the Board President.

Members of the public must be recognized by the Board President before they can address the Board or participate in discussion on the agenda item being addressed during the meeting. The person that is recognized to speak will need to clearly state his/her name for the record.

The Board President can limit the amount of time for public comment and discussion on any agenda item.

During any meeting of the Board, if there is inappropriate conduct, comments or unprofessional statements made during the meeting towards the Board, OBCE staff or others in attendance at the meeting a verbal warning will be given by the Board President.
