**Description of Amendment:**

a. This is to incorporate the following:

Amendment 1 is issued to answer the following questions:

1. Would the State consider the following modifications (italicized and in bold) to the insurance requirements of the RFP? **No, modifications to section A are not accepted.**

Page 10 of 34, Section A.26. Insurance

“The contractor shall maintain and provide proof, *in the form of standard ACORD form types certificates of insurance*, to the State of the following insurance during the term of this agreement:

- a) Worker’s Compensation and Employer’s Liability Insurance in accordance with applicable law.
- b) Commercial General Liability Insurance on a per occurrence basis with limits of liability not less than \$1,000,000 per occurrence and aggregate combined single limit, Personal Injury, Bodily Injury and Property Damage.
- c) Automobile Liability Insurance with limits of liability of not less than \$1,000,000 per *accident or* occurrence combined single limit including Bodily Injury and Property Damage. Coverage shall include all owned vehicles,

b. All other terms and conditions remain unchanged.

The State shall not be precluded from receiving the benefits of any insurance the Contractor may carry which provides for indemnification for any loss or damage to property in the Contractor's custody and control where such loss or destruction is to State property."
