**9. Director’s Report**

Steve Emmons presented his Director’s Report. Among his report were the following:

- The Bridge and Basic academy are now combined. All cadets will attend the first 10 weeks. On Friday of the 10<sup>th</sup> week, cadets eligible for Bridge Academy certification will take the certification exam while the remainder of the cadets continue on for the rest of the full Basic Academy.  
There will be only one graduation per academy. If Bridge cadets wish to participate in a formal graduation, they will do so with the regular graduation of the Basic Academy to which they attended.
- Beginning with the first Basic Academy in 2015, cadets will be required to bring and wear helmets in Custody Control/Defensive Tactics. Agencies with cadets scheduled to attend have been informed of the helmet specifications, which was approved by the Council.
- With the retirement of Chris Sutterfield, Operations Manager, Shannon Butler was promoted from Academy Coordinator to Training Manager effective December 01, 2014.
