**1. Call Meeting to Order**

At 1:08 p.m. Chairman McNickle called the meeting to order. Roll was called and nine of twelve members were present representing a quorum.

**2. Proposed Executive Session to include matters pursuant to 25 O.S. 1995, Section 307(B1): “Discussing the employment, hiring, appointment, promotion, demotion, disciplining or resignation of any individual salaried public officer or employee”, the Assistant Director of CLEET.**
