CALL TO ORDER

The Oklahoma Conservation Commission met Monday, August 1, 2016, at the Agriculture Building Board Room located at 2800 N. Lincoln in Oklahoma City, Oklahoma. The meeting was called to order at 9:30 a.m. by Chairman Scotty Herriman. He stated this was a Regular Meeting scheduled in accordance with the Open Meeting Law, Title 25, Oklahoma Statutes, Sections 301 and following as amended. The agenda for this meeting was posted on July 28, 2016, at the front entrance of the building.

MINUTES OF PREVIOUS REGULAR MEETING

Sheryl Gibson, Financial Management and Human Resources Assistant Director, presented the claims and financial statement as listed in Exhibit #1. JOINT PLANS OF OPERATION

Ms. Owen presented FY2017 Joint Plans of Operation for approval as listed in Exhibit #5. A motion was made by Mr. Jett and seconded by Ms. LeGrand to approve the plans as listed. Those voting aye were: Jett, Rooker, Herriman, LeGrand and Clark. Nay votes: none. Motion carried.

PUBLIC COMMENTS

None.

NEW BUSINESS

Ms. Owen stated that three agreements came in on Friday, July 29 requiring Commission approval. The following agreement needed approval before August 1 so it will need to be ratified as it was approved by Mr. Herriman:

- 1) Natural Resources Conservation Service (NRCS) No. 68-7335-16-502 to update watershed fact sheets, EAPs, assist with implementation of DamWatch, provide up-to-date GIS data, and complete hazard classification review.

A motion was made by Ms. LeGrand and seconded by Mr. Rooker to ratify approval of the new agreement as presented. Those voting aye were: Jett, Rooker, Herriman, LeGrand and Clark. Nay votes: none. Motion carried.

Ms. Owen submitted the following two new agreements and recommended approval:

- 2) NRCS No. 68-7335-16-211 for the rehabilitation of Barnitz Creek Site 5 in Dewey County; and
- 3) Poteau Valley Improvement Authority to provide funding for water quality monitoring in the Wister Lake Watershed in support of watershed planning.

A motion was made by Mr. Clark and seconded by Ms. LeGrand to approve the new agreements as presented. Those voting aye were: Jett, Rooker, Herriman, LeGrand and Clark. Nay votes: none. Motion carried.

CONSERVATION PARTNERSHIP REPORTS

Oklahoma Department of Agriculture, Food and Forestry: Betty Thompson, Deputy Commissioner, reported that the Women in Ag project will be released this week. The purpose is to recognize women in ag in the fields of entrepreneurship, leadership, education and trail blazers.

Jeremy Seiger, Agricultural Environmental Management Services Director, stated that in 2012 the U.S. Environmental Protection Agency delegated the National Pollutant Discharge Elimination System to the Department. Five year permits were obtained which will expire this year. The Department is working to renew the pesticide general permit and the Concentrated Animal Feeding Operation general permit, both of which fall under the Clean Water Act. The renewals will be sent out for comment from stakeholders then a public notice for comments will be published.

USDA-Natural Resources Conservation Service: Gary O'Neill, State Conservationist, provided a written report. He detailed the report noting the story regarding Mr. Herriman and the field day he hosted. Mr. O'Neill attended a field day in Dewey County. The report has an article on the student interns. He stated that a proposal is being developed for an on-site hiring event for students to be held at Langston University.

Mr. O'Neill stated that a new version of the Client Gateway is available; however, he noted that the number of people using it in Oklahoma is low. A marketing campaign will commence for this tool.

Mr. O'Neill noted there is an article regarding the National Land and Range Judging Contest and event coordinator Don Bartolina, Oklahoma County Conservation District Manager.

As the fiscal year comes to a close staff will be finalizing agreements with partners. Oklahoma is one of four states receiving a Regional Conservation Partnership Program review.

Oklahoma Association of Conservation Districts: Steve House, President, attended demonstration farm field days in Goldsby and in Leedey. He stated the National Association of Conservation Districts South Central Meeting is this month. The Executive Board will meet on August 16 to begin planning for the area and state meetings.

OKLAHOMA CONSERVATION COMMISSION MEMBERS

Mr. Jett reported on attending the Field Day in Leedey and expressed his appreciation to Jimmy Emmons for hosting such a great event. He also attended a Plant ID Workshop in Beaver. Mr. Jett reported that the first meeting of his district's youth board will be held on Tuesday.

Mr. Clark reported on attending the Cattlemen's Association annual meeting.

Mr. Herriman also attended the Field Day in Leedey and echoed Mr. Jett's words regarding the event and Mr. Emmons.

OKLAHOMA CONSERVATION COMMISSION STAFF

Executive Director: Mr. Lam stated a written report is in the packet. He reported on attending the demonstration farm event in Goldsby as well as the field day in Leedey.

Water Quality Program: Shanon Phillips, Director, stated a written report is in the packet. She reported on attending the Soil and Water Conservation Society meeting in Louisville, Kentucky and stated that Oklahoma was recognized for its successful partnerships. The North Canadian River project and the Honey Creek project were mentioned during a keynote address. Ms. Phillips reported that NRCS Chief Jason Weller highlighted Oklahoma's partnership in his address. She also stated that three presentations used maps produced by the Commission's Office of Geographic Information and Technical Services Division.

Ms. Phillips reported that Cheryl Cheadle, State Blue Thumb Coordinator, is retiring September 1 so this will be her last Commission meeting. A retirement celebration is planned for August 30. Ms. Cheadle expressed her appreciation to the Commission members, the conservation district directors and employees, OACD and NRCS. Mr. Herriman expressed his appreciation to Ms. Cheadle.

It was noted that the Blue Thumb Volunteer Conference is August 23-24 in Hinton.

Office of Geographic Information and Technical Services: Mike Sharp, Director, stated a written report is in the packet. He has been working with the NRCS on LIDAR. The NRCS, Federal Emergency Management Agency and the U.S. Geological Survey are all working to get LIDAR on the entire state and hopefully by next year at this time all will be complete except the panhandle.

Abandoned Mine Land Reclamation Program: Robert Toole, Director, stated a written report is in the packet. He stated the program continues its mission to protect lives, repair scarred lands and improve the environment. He stated two projects are under construction. Recent rains have been good for the vegetation but there was wind damage to the Northeastern State University project. He stated that solicitations for American Burying Beetle surveys are being finalized along with the Long-eared Bat Surveys. He stated that due to a sighting of an Indiana Bat in LeFlore County a survey for that specie will have to be conducted on all projects in that county along with the Northern Long-eared Bat.

Mr. Toole stated that designs are being completed and construction contracts are being prepared for reclamation of two surface mines and two underground mines projects and work should commence by November.

Conservation Programs: Tammy Sawatzky, Director, stated a written report is in the packet and she yielded for questions.

Assistant Director: Ms. Owen stated a written report is in the packet. She reported that work continues with Oklahoma State University for a shared services agreement and a meeting will be held next week in Bryan County for finalization. Ms. Owen reported that the internship in Garvin/Murray County concluded and she expressed her appreciation to Grant Couch for the work he did. The internship was timely as that area was understaffed due to injuries and a retirement.

Ms. Owen stated that the Journal Record ran a story on the tour held in Seminole County for watershed emergency repairs and a story on Mr. Herriman's field day. She also reported that Mr. Clark was recognized at the Cattlemen's Association for his work with their scholarship program.

Ms. Owen reported that the Commission has made payments to FEMA for the Sugar Creek project and hopefully that project will be finalized in October.

The next regular meeting of the Oklahoma Conservation Commission will be held on Thursday, September 1, 2016, in the Agriculture Building Board Room, 2800 N. Lincoln Boulevard, Oklahoma City, Oklahoma beginning at 9:30 a.m.

I. GENERAL

The Oklahoma Conservation Commission hereby declares that the following problems are having a detrimental effect on the renewable natural resources of our state:

Populations of the monarch butterfly (*Danaus plexippus*) have experienced alarming reductions during the past 20-plus years. The decline in the subspecies (*Danaus plexippus plexippus*) that breeds east of the Rocky Mountains has been identified as being of particular concern. Several factors, including the absence of naturally occurring fires within this region of Oklahoma and the encroachment of eastern red cedar is altering the vegetation structure of native grasslands, resulting in more brush and tree species and less native bunch grasses and nectar-producing forbs across the landscape.

Through conservation programs and technical assistance, OCC will work with partners and clients to improve and/or increase monarch habitat on private lands along the I-35 monarch migratory corridor in Oklahoma.

The Conservation Commission herein establishes the complete list and description of the Monarch Habitat Improvement Cost-Share Program policies and conservation practices approved for use by the conservation districts during this program year. See Section II for the approved list of conservation practices with their respective range of cost-share rates for each of the Monarch Habitat initiatives. Cost-share unit costs are based on Oklahoma Natural Resources Conservation Service (NRCS) Monarch Habitat Development data.

Any exceptions from these established Monarch Habitat Initiative Program policies and guidelines shall be approved by the Conservation Commission.

II. ALLOCATION OF FUNDS

A. Monarch Habitat Initiative

The Conservation Commission allocates \$102,400 of USFWS grant funds for the purpose of providing cost-share payments to eligible participants for implementing approved cost-share conservation practices to improve monarch habitat.

B. Conservation District Allocation

Cleveland County Conservation District, Logan County Conservation District, McClain County Conservation District and Oklahoma County Conservation District will each receive \$25,600 in which to implement the Monarch Habitat Initiative cost share program. These funds will be available to the conservation districts on September 1, 2016.

Each district may choose to use up to \$1,000 for establishment of monarch way stations within established public outdoor classroom sites and/or city parks.

III. POLICIES

A. Allocation Period

The allocation period shall start September 1, 2016 and end January 31, 2017. Any funds allocated to districts and not obligated during the allocation period for Program Year 1 will be released by the district and made available for reallocation by the Conservation Commission. Funds become obligated to a participant after approval of the application by the board and a performance agreement has been signed and dated by the district board and the participant.

B. Authorized/Designated Representatives

The district board must designate an authorized district representative. This person can sign all forms. The authorized district representative must be a district board member. It cannot be a district employee.

The district must designate a technical representative. The designated technical representative will assist in developing conservation plans and determining the need for conservation practices. The representative will also be responsible for design and layout of approved conservation practices, determining compliance with approved standards and specifications, and certifying conservation practice quantities and completion of conservation practices.

C. Conservation Practices

Each district board may select any of the approved cost-share conservation practices within the Monarch Habitat Initiative for inclusion in the district's local guidelines. The selection should be based on which practices will best address the district's highest priority problems affecting monarch habitat.

Cost-share practices shall be implemented according to NRCS standards and specifications. In the event NRCS standards and specifications do not exist, conservation practices must meet Conservation Commission approved standards and specifications.

D. Unit Costs

Unit costs for these practices are based on Oklahoma NRCS data. In order for a variance to be considered the request must be in writing and accompanied by supporting data compiled by the district. The variance must be approved by the Conservation Commission prior to the board's approval of Program applications and performance agreements being signed.

E. Cost-Share Payments

The minimum cost-share payment amount that shall be made to any participant from these funds is \$100. The maximum cost-share payment amount that shall be made to any participant from these funds is \$5,000.

F. Eligibility

Applicants for the Monarch Habitat Initiative must be a district cooperator with a conservation plan.

Conservation Commissioners, Conservation Commission staff, conservation

district employees or the spouses of any of these people shall not be eligible to participate in the Conservation Cost-Share Program.

Conservation district directors are eligible to participate in the Monarch Habitat Initiative Cost - Share Program. However, due to the limited amount of funds available for this program individual directors should give careful consideration to public perception when making their decision to participate in the Program. If the local board decides that board members can apply and board members choose to apply for the program; the guidelines listed below must be followed.

1. Individual district board members applying cannot discuss any element of the Cost-Share Program including but not limited to practices, unit costs, selection criteria, application approval/disapprovals, cost-share payments, and extensions.
2. Individual district board members applying for the Cost-Share Program must abstain from voting on all elements of the Program.
3. Individual district board members cannot use their position as a conservation district board member to improve or elevate their individual chances of becoming a successful applicant.

G. Agreements

All performance agreements must be signed and dated by the district board and participant on or before January 31, 2017. All Program performance agreements must be completed and the check in the hand of the participant on or before December 31, 2017. Installation of conservation practices cannot begin until an effective performance agreement is in place. A performance agreement becomes effective on the last date of signature. Each participant should have only one performance agreement.

In addition to the performance agreement; landowners will be required to sign a Partners for Fish and Wildlife Program Landowner Agreement as prescribed in Exhibit A.

IV APPROVED CONSERVATION PRACTICES

Contained in this section is a list of all conservation practice's approved for use in the Monarch Habitat Initiative. The conservation districts shall only use conservation practices listed here unless a special request is approved by the Conservation Commission. In order for a conservation practice special request to be considered the request must be in writing and accompanied by supporting documentation. The special request must be approved by the Conservation Commission prior to the board's approval of Program applications and performance agreements being signed.

Unit cost for these practices is based on Oklahoma NRCS data. In order for a variance to be considered the request must be in writing and accompanied by supporting data compiled by the district. The variance rate must be approved by the Conservation Commission prior to performance agreements being signed.

Below are the conservation practices approved for the Monarch Habitat Initiative.

314 - Brush Management

Definition: The management or removal of woody (non-herbaceous or succulent) plants including those that are invasive and noxious.

Purpose: Create the desired plant community consistent with the ecological site.

- Restore or release desired vegetative cover to protect soils, control erosion, reduce sediment, improve water quality or enhance stream flow.
- Maintain, modify or enhance fish and wildlife habitat.
- Improve forage accessibility, quality and quantity for livestock and wildlife.
- Manage fuel loads to achieve desired conditions.

315 – Herbaceous Weed Control

Definition: The removal or control of herbaceous weeds including invasive, noxious and prohibited plants.

Purpose: • Enhance accessibility, quantity and quality of forage and/or browse.

- Restore or release native or create desired plant communities and wildlife habitats consistent with the ecological site.
- Protect soils and control erosion.
- Reduce fine-fuels fire hazard and improve air quality.

327 – Conservation Cover

Definition: Establishing and maintaining permanent vegetative cover.

- Purpose:**
- Reduce sheet, rill and wind erosion and sedimentation.
 - Reduce ground and surface water quality degradation by nutrients and surface water quality degradation by sediment.
 - Reduce emissions of particulate matter (PM), PM precursors and greenhouse gases.
 - Enhance wildlife, pollinator and beneficial organism habitat.
 - Improve soil health.

338 – Prescribed Burning

Definition: Controlled fire applied to a predetermined area.

- Purpose:**
- Control undesirable vegetation.
 - Prepare sites for harvesting, planting or seeding.
 - Control plant disease.
 - Reduce wildfire hazards.
 - Improve wildlife habitat.
 - Improve plant production quantity and/or quality.
 - Remove slash and debris.
 - Enhance seed and seedling production.
 - Facilitate distribution of grazing and browsing animals.
 - Restore and maintain ecological sites.

382 – Fence (only to be used in conjunction with Practices 327, 386, 390 and 550

Definition: A constructed barrier to animals or people.

Purpose: This practice facilitates the accomplishment of conservation objectives by providing a means to control movement of animals and people, including vehicles.

386 – Field Border

Definition: A strip of permanent vegetation established at the edge or around the perimeter of a field.

Purpose:

- Reduce erosion from wind and water.
- Protect soil and water quality.
- Provide wildlife food and cover and pollinator or other beneficial organism habitat.
- Increase carbon storage.
- Improve air quality.

390 – Riparian Herbaceous Cover

Definition: Grasses, sedges, rushes, ferns, forbs and legumes that are tolerant of intermittent flooding or saturated soils and are established or managed as the dominant vegetation in the transitional zone between upland and aquatic habitats.

Purpose: This practice may be applied as part of a conservation management system to accomplish one or more of the following purposes:

- Provide or improve food and cover for fish, wildlife, or livestock.
- Improve and maintain water quality.
- Establish and maintain habitat corridors.
- Increase water storage on floodplains.
- Reduce erosion and improve streambank and shoreline stability.
- Enhance pollen and nectar production and provide nesting sites for pollinators.
- Increase net carbon storage in the biomass and soil.

550 - Range Planting

Definition: Establishing of adapted perennial or self-sustaining vegetation such as grasses, forbs, legumes, shrubs and trees.

Purpose:

- Restore a plant community similar to the Ecological Site Description reference state for the site or the desired plant community.
- Provide or improve forages for livestock.
- Provide or improve forage, browse or cover for wildlife.
- Reduce erosion by wind and/or water.
- Improve water quality and quantity.
- Increase carbon sequestration

This Landowner Agreement (Agreement), dated _____, between landowner _____, the _____ Conservation District, the Oklahoma Conservation Commission, [Cooperator(s)], and the U.S. Fish and Wildlife Service (Service) is entered into pursuant to authority contained in the Partners for Fish and Wildlife Act (P.L. 109-294), the Fish and Wildlife Coordination Act (16 U.S.C. 661 et seq.) and the Fish and Wildlife Act of 1956 (16 U.S.C. 742a-j), as amended. This project was selected for funding because the Landowner share a common objective with the Service to restore habitat for the benefit of Federal trust species on private lands, and the project supports priority actions identified in the Regional Partners for Fish and Wildlife (Partners) Program Strategic Plan.

_____ (Landowner), hereby agrees to participate with the Service in conducting certain wildlife management practices on lands owned or managed in _____ County, State of Oklahoma, described as follows: all of, or within, Section _____, T _____ N-R _____.

In signing this Agreement, the Landowner joins as a participant in a wildlife habitat improvement program and grant to the Cooperator and the Service authority to complete the habitat improvement project or the Landowner may personally carry out management activities with financial or material support as described by the _____ Conservation District. Any donation of supplies, equipment, or direct payment from the Cooperator to the Landowner for carrying out the habitat improvements is included in the Performance Agreement. The activities conducted pursuant to this Agreement are not to replace, supplement or otherwise contribute to any mitigation or compensation that may be required of the Landowner or Cooperator, or other parties, as a result of any mandated requirements.

The term of this Agreement (also referred to as the habitat retention period) will be completed by _____. This Agreement may be modified at any time by mutual written consent of the parties. It may be terminated by either party upon 30 days advance written notice to the other party(ies). However, if the Landowner terminate(s) the Agreement before its expiration, or if the Landowner should materially default on these commitments, then the Landowner agree(s) to reimburse the Cooperator prior to final termination for the prorated costs of all habitat improvements placed on the land through this Agreement, and the Cooperator will work with the Service to determine how those funds will be used. For these purposes, the total cost of the habitat improvements to the United States is agreed to be \$ _____.

Landowner:

The Landowner or his/her land manager, with legal authority over land management decisions, guarantee ownership of the above-described land and warrants that there are no outstanding rights that interfere with this Landowner Agreement.

The Landowner will notify the Service and other Cooperator of planned or pending changes in ownership. A change of ownership shall not change the terms of this Agreement. The Agreement and terms shall be in effect on the described land for the term of the Agreement.

The Landowner agree(s) to allow access (with advance notice) to the Service and the other cooperating partner to implement the project described in Exhibit A, and to monitor project success.

The Landowner retain(s) all rights to control trespass and retains all responsibility for taxes, assessments, and damage claims.

During the habitat retention period, the landowner must maintain the habitat restored under this award for a period of ten years from the project completion date. This means to leave adequate nesting cover of native warm season grasses/forbs and legumes. This cover will be utilized by ground nesting birds and the monarch butterfly.

At the end of the habitat retention period, the habitat improvement project will become the sole property and complete responsibility of the Landowner. There shall be no obligation to the Service after the term of the Agreement has expired.

The Landowner will be responsible for securing any necessary permits. The landowner must notify Okie Locate to make sure that all pipelines, electric lines, phone lines or other dangerous issues are marked before starting the project. The Landowner and Cooperator agree(s) to identify the Service's contribution to the project during public presentations, reports, or other information published about the project, as appropriate.

The Landowner will not be responsible for replacing wildlife habitat developments that are damaged or destroyed by severe acts of nature].

Service:

The Service will work with the Landowner and Cooperator(s) signing this Agreement, throughout the entire Agreement term to support actions needed to ensure that the project is designed and constructed per the Agreement and functions as intended.

The Service, its agents, or assignees will provide advanced notice prior to accessing the Landowner property to implement the project described in the work plan, and to monitor project success.

The Service assumes no liability for damage or injury other than that caused by its own negligence, on the above acreage. The Service does not assume jurisdiction over the premises by this Agreement.

Spatial Information Sharing: In accordance with the Privacy Act of 1974, permission must be obtained from the Landowner before any personal information can be released. The only information that can be shared is payment information that is authorized by law. Therefore, Landowner consent is requested to allow for sharing of spatial information about this project solely with conservation cooperators providing technical or financial assistance with the restoration, enhancement or management of fish and wildlife habitat.


