The purpose of the National Criminal History Improvement Grant is to assist states in meeting various evolving federal and state requirements regarding criminal history and related records.

In 2015, the State of Oklahoma received \$1,611,078.00. The Oklahoma State Bureau of Investigation, Sequoyah County, Oklahoma County, and Custer County County received five (5) federal awards because the projects focus on the exchange of data between law enforcement and the Courts.
