Who Can Apply	Applicants may include state agencies, state, local, or tribal courts, units of local government (city, counties, towns, police departments, sheriff's departments), Indian tribal governments, public or private nonprofit organizations including faith based organizations, nongovernmental victim services programs that are certified by the Office of the Attorney General. Tribes are exempt from the certification requirement.	To be eligible for funding from the SASP Grant, an applicant must be a non-governmental or tribal victim services program. The victim service providers must be certified through the Office of the Attorney General. Victim service providers from federally recognized Indian tribes are exempt from this requirement. OVW has prioritized projects that can and will promote civil rights (including meeting the needs of underserved and marginalized survivors), improving access to justice for survivors, and enhancing survivor safety.
