

Session Descriptions

Leadership, Liability and Prioritization of Violence Against Women Crimes

This presentation explores leadership responsibility in the epidemic of violence against women crimes in our country. We will discuss the interconnected nature of sexual assault – intimate partner violence – stalking, including the impact of a culture of sexual violence on law enforcement and the communities they serve. We will discuss how leaders can effectively communicate and make prevention and response to these crimes a priority to ensure victim/survivor safety, enhance public trust and reduce liability while promoting a vision that will help end violence against women crimes.

Working with the Media in the Wake of a High Profile Violence Against Women Crime; The Kidnapping, Rape and Murder of Michele Gardner Quinn

Managing the media in the wake of a high profile crime of violence can be challenging, especially when the crime receives national attention. This discussion will review the strategies that law enforcement, community leaders and advocates need to consider while working through the complexities of the investigation, including managing the media, addressing the fears of the community, and bringing the offender to justice.

We will discuss investigative strategies to help officers make a predominant aggressor determination, including a discussion on injury analysis and self-defense.

Neurobiology of Trauma

This presentation will be a combination of lecture and audience participation on the topic of trauma and its psychobiological effects. The presentation will begin with an exploration of the nature of traumatic events and the difference between normal, situational, and traumatic stress. Next, physiological components of trauma will be introduced, such as brain structures and biochemistry, and the essence of phenomenon such as dissociation, hyper-vigilance, and flashbacks will be explored.

Domestic Violence Testimony

This workshop will offer law enforcement officers the opportunity to work on domestic violence case scenarios and testify in a mock court trial.

Working with Latino Males Who Batter

This presentation will answer the questions of, "What is culture?" and "What data do we have on Oklahoma demographics and Hispanic/Latino immigrants?" Participants will be provided with an overview on the continuum of differences relating to specific cultural conventions, the impact of machismo, beliefs of machismo, along with the role of history and culture in developing this belief and others that impact interventions to Hispanic/Latino offenders.

Identifying and Working with Secondary Trauma

This workshop will explore the phenomenon of secondary trauma, including the use of an assessment tool can then be used to create plans for ameliorating vicarious trauma with the group as a whole, or with specific individuals. Implications for secondary trauma will be discussed and current holistic interventions in mitigating the secondary post-traumatic stress response for helping professionals will be presented.

Bringing Sexual Violence Prevention into Community Oriented Policing

Using personal stories, humor, and lots of practice, the *My Body, My Life* program helps girls and women in Norman, OK develop self esteem and boundary setting, build skills to recognize unsafe relationships and situations and the tools to protect themselves. Sergeant Moore and Master Officer Savage will discuss why and how law enforcement can include sexual violence prevention as part of their community crime prevention programs.

My Body, My Life: Moving Beyond Defensive Tactics for Girls and Women

An interactive presentation that focuses on a sexual violence prevention program developed and implemented by law enforcement in middle and high school and for adult women. *My Body, My Life* combines awareness and defensive tactics with self-esteem and boundary setting skills to enhance self protective skills.

Trauma Informed Care Part 1

This workshop will teach participants what trauma is including the behavioral, physical, and emotional effects of trauma. Participants will be invited to learn the difference between trauma informed and trauma focused care.

A Three-Phase Treatment Model for Working with Adult Survivors of Childhood Sexual Abuse

This presentation will outline a three phase clinical model useful for providing treatment to adult sexual assault survivors. Clinical case scenarios will be used to illustrate the practical application of each of the model's phases.

Child Abuse and Exploitation 101: Basic Investigative Framework

This workshop examines a standard Law Enforcement approach to the investigation of child physical and sexual abuse as well as exploitation. The class is designed to provide the novice investigator a basic understanding of a Multi-Disciplinary Team approach to investigations involving child physical and sexual abuse. The presenter will discuss strategies for conducting investigations and use examples from Investigations conducted by the Norman Police Department. Included in the discussion will be the overall investigative process, techniques utilized in these cases, forensic interview procedures, and lessons learned.

Trauma Informed Care Part 2

Part 2 of this workshop focuses on understanding burnout, vicarious trauma, secondary traumatic stress, and compassion fatigue. Participants will be invited to learn about organizational trauma and to understand the ABCs of self care. This will include a self assessment and a personal self-care plan.

Speaker Biographies

Thomas Tremblay: Throughout his distinguished thirty year policing career, Tom Tremblay has been a passionate leader for the prevention of sexual violence. He is a national trainer and advisor promoting improved victim services, multi-disciplinary response and investigations, greater offender accountability, and the importance of law enforcement leadership, policy and training to help end violence against women crimes. Tom holds a Bachelor's Degree in Criminal Justice. He is a graduate of the 183rd Session of the FBI National Academy, the FBI Law Enforcement Executive Development Seminar, the Police Executive Research Forum—Senior Management Institute for Police, and the National Law Enforcement Leadership Institute on Violence Against Women.

Cathy Olberding, LPC has over 25 years experience as a lead therapist, program manager, Chief Operating Officer, Detention Administrator, Assessment and Referral Director and trainer in a variety of settings including youth shelters, group homes, secure institutions, hospitals and mental health clinics. In addition, she is a therapist in a private forensic mental health practice where her clients include women with extensive histories of abuse and neglect who have been previously incarcerated. As an advocate for individuals affected by abuse, neglect and mistreatment, Cathy has presented training and workshops at local, regional, state and national conferences in the areas of trauma informed care, adolescent sex offender treatment, sexual abuse, mental health issues in juvenile justice and the unique treatment needs of girls in the justice system.

Missi Iski, MA, LPC, LMFT has been the Director of Programs and Counseling at Domestic Violence Intervention Services/Call Rape since 1999 and is in private practice. She has provided mental health services for adults, adolescents, children and families for over thirty years. Ms. Iski has extensive training in trauma treatment and EMDR and has trained Mental Health Professionals in Oklahoma, in other states and in Canada on trauma and recovery for domestic violence survivors.

Sheree L. Hukill, MS, JD is a professional educator whose experience spans over 28 years and includes work in business, education & law. She has served as Executive Director/Supervising Attorney & co-founder of a state-wide, tribal domestic violence coalition; grant-writer for numerous Indian tribes and service organizations; founding partner of Legal Advocates for Indian Country, LLP; court appointed counsel for women & children in juvenile deprived actions; public defender and prosecutor for several Indian tribes; national speaker on domestic violence/sexual assault issues & peer review consultant for the Office on Violence Against Women.

Sharolyn Wallace, PhD., LCSW, Registered Play Therapist Supervisor has been the Professor of Human Services at Tulsa Community College for 17 years. She is also the director for TCC's Center for Addiction Prevention and Recovery Support. Dr. Wallace serves as adjunct faculty for Southern Nazarene University, University of Oklahoma, and Langston University. She is the President Elect for OK NASW. Dr. Wallace has been in private practice for over twenty years specializing in child sexual abuse and trauma. Dr. Wallace led a team of mental health workers providing crisis intervention and play therapy in Sri Lanka one month following the Tsunami. She has also provided crisis relief work in Alaska, New York, Miami, San Francisco, and Scotland, and two separate tours of duty in New Orleans in the aftermath of Hurricane Katrina. Dr. Wallace has published articles on play therapy and relapse prevention with child welfare families.

Lesley March, JD received her B.A. (English) 1980 from the University of Oklahoma and was awarded her Juris Doctorate from the University of Oklahoma in 1983. She practiced law with her father, Bob A. Smith and was a partner in the firm of Smith and Smith from 1983 until March of 1998. She is a member of the McClain County Bar Association, Past President of the McClain County Bar Association, a member of the Logan County Bar Association, a member of the Oklahoma Family Law

Section of the Oklahoma Bar Association and a member of the Ruth Bader Ginsburg Inn of the Court. She has served on the Board of Directors for Oklahoma Indian Legal Services as well as the Sequoyah Girls Home in Chickasha, Oklahoma. She also served on the Board of Directors for the Chickasha Women's Service and Family Resource Center for 12 years and served as Board President 2010-2011. In September of 2011, March became the Chief of the Victim Services Unit of the Office of the Attorney General.

Ann Dapice, PhD received a doctorate in psychology, sociology and philosophy from the University of Pennsylvania. She has taught and served as administrator at a number of universities including the University of Pennsylvania, Widener University, Penn State University, Goddard College, Northeastern Oklahoma A & M College, and Tulsa Community College, teaching courses in the social sciences, philosophy and Native American Studies. Her cross-cultural and interdisciplinary research has been reported in professional journals, books, and academic presentations regionally, nationally and internationally. Recently she completed the following book chapters for publication in an International volume on Violence by Praeger-Greenwood Publishers: "Stalking of Indians, Coincidence or Conquest," "Violence in the Brain," "Betrayal, Revenge and Religion: Selective Denial of Violence," "Bullying Then and Now." She has served as officer and on the Elders Council for the American Indian Chamber of Commerce and served two terms as a member of the Board of Directors of Mental Health Association in Tulsa where she serves on the Education Committee.

Janine D'Anniballe, Ph.D., has been dedicated to the prevention, treatment, and training of sexual assault issues for the past 18 years. Currently, she is the Director of Access, Emergency, and Community Services at Mental Health Partners in Boulder, Colorado. Previously, she was the Executive Director of Moving to End Sexual Assault (MESA), the rape crisis center in Boulder, Colorado for ten years. She received her Ph.D. in Counseling Psychology from the University of Tennessee. Dr. D'Anniballe has provided training and consultation to attorneys, law enforcement, military personnel, mental

health professionals, victim advocates and University staff in more than 30 states across the country. She serves as a trainer for the Ending Violence Against Women Project for the State of Colorado, providing training throughout the state addressing system response issues in sexual assault cases. In 2003, Dr. D'Anniballe joined the faculty of the National Judicial Education Program that educates judges on sexual assault issues and how these cases are approached in the courtroom so as to minimize re-traumatization of victims without undermining defendants' constitutional rights.

Ronnie Johnson is an 11-year veteran law enforcement. Ronnie has been certified by the Federal Law Enforcement Training Center (FLETC) as a domestic violence instructor and by the Council on Law Enforcement Education and Training (CLEET) as a state instructor. In 2009, he received the State of Oklahoma Law Enforcement Officer of the Year *Award for Excellence in Action Against Domestic Violence*.

Sergeant Raymond Goins has been an officer of the Norman Police Department since March 1997. While serving with them, he has been assigned additional duties as a Technical Investigator (CSI), Drug Recognition Expert (DRE Instructor qualified), academy instructor of basic forensic investigation, DUI enforcement/SFST and domestic violence investigation. Sgt. Goins has coordinated the domestic violence in-service training for the department and has been certified by the Federal Law Enforcement Training Center (FLETC) as a domestic violence instructor. He is also a member of the Cleveland County Domestic Violence Task Force, Cleveland County Domestic Violence Coordinated Community Response Team, Sexual Assault Response Team and Board of Directors for the Cleveland County Women's Resource Center.

Cindy Garcia, M.A. has a B.A. in Spanish and an M.A. in Marriage and Family Therapy. She lived and worked in Mexico for 22 years, mainly in the area of education. She holds a current Oklahoma teaching certificate for K-12 for Spanish and is a LPC under supervision, providing therapy for Spanish speaking

victims of child trauma and adult survivors of sexual abuse or assault at the Latino Community Development Agency. Cindy was trained by Dr. Antonio Ramirez of CECEVIM, on a culturally specific model for Batterer's Intervention and supervises the DV/SA and Batterers Intervention Programs at LCDA.

Sergeant Robert Moore, LPC is a 28 year veteran of the Norman Police Department, a defensive tactics instructor, a Licensed Professional Counselor through the State of Oklahoma, a husband, and a father of three daughters and a son.

Master Police Officer Marcus Savage is a 7 year veteran of the Norman Police Department, a SWAT team member, a Gunnery Sergeant in the United States Marine Corps, a husband, and a father of three daughters and two sons.

Gwendolyn Downing, LPC loves her job! As the Coordinator of Trauma Informed Services for the Department of Mental Health and Substance Abuse Services, she is able to carry the message of the power and healing of trauma informed care. Not just for those we serve, but for ourselves and each other. She received both her degrees and was raised in Oklahoma, but does not watch football. She lives with one very "special" puppy, named Zaccheus, and her favorite other name is "Auntie." Gwen has worked in medical, education, faith based, and behavioral health systems, and is a Kids Count leader. She is a passionate presenter, who believes that hope is the core message regardless of the material.

Detective John Stege is a 17 year veteran with the Norman Police Department and also spent 8 years as a Military Police Officer in the US Army. He currently serves in the Child Victim Unit where he investigates crimes involving children including cases of sexual abuse, serious physical abuse, and neglect. Along with his duties as an investigator he is a trained forensic interviewer and proud to be associated with the Mary Abbott Children's House which is the Child Advocacy Center for District Attorney's region 21

(McClain, Cleveland, and Garvin counties).

Rachelle Harjo, MA, LPC, NCC owns her own private practice serving Logan, Kingfisher, and Oklahoma City counties primarily working with individuals, families and groups of all ages. She has worked with individuals who self harm since 2001 in New Mexico and then started in 2006 in Oklahoma on an outpatient behavioral health basis as a licensed professional. She has also worked with the domestic violence and sexual assault communities related to self-harm prior to 2001 in New Mexico as a non-licensed professional. She is married and has three children ages 18, 10, and 5. Her husband is Choctaw-Creek and they are very involved with the Native American communities in surrounding areas.

Dawn Stover is a citizen of the Cherokee Nation of Oklahoma and serves as the Executive Director of the Native Alliance Against Violence (NAAV), Oklahoma's Tribal Domestic and Sexual Violence Coalition, serving Oklahoma's federally recognized tribes, and domestic and sexual assault programs and staff. Dawn has worked towards ending violence against women professionally through her work at NAVV and previously in her 10 years as director of the Oklahoma Regional Community Policing Institute (ORCPI). Dawn's areas of expertise include curriculum development, grant development and management, and non-profit management. Dawn is an advocate for social change and justice and is passionate about the work to end violence against Native women.


