- c. Craiton Cooper made the motion to rewrite Question 46 on the LPG test Version 4.0 for the purpose of clarification of the question. Charles Lawson seconded the motion.

- a. Peggy Beaty asked the Committee to review the current test versions. It was determined LPG versions 1.0 and 4.0 were valid tests; CNG versions 1.0 and 1.1 were valid tests; EV test was valid as well.
