Agenda Item 1 - Call to Order

Governor Henry called the meeting to order at 2:35 p.m. A roll call was taken and a quorum was established. The Governor was advised that Notice of the meeting had been given, and an Agenda posted in accordance with the Open Meeting Act.

Agenda Item 2 - Approval of Minutes

Mr. Richard moved approval of the Minutes of the July 22, 2009 meeting. Mr. Watkins seconded the motion and it carried with the following votes: Lt. Governor Askins, yes; Mr. Meacham, yes; Mr. Hendrick, yes; Mr. Richard, yes; Mr. Ridley, yes; Mr. Watkins, yes; and Governor Henry, yes.

Agenda Item 3 – Discussion and possible action authorizing selection of service providers for a bond issue of approximately \$2.6 million for the School of Science and Mathematics authorized by 73 O.S. \$168.3, including distribution of requests for proposals, review by a screening committee and other action deemed necessary by the Authority Secretary, with selection of providers subject to final action by the Authority.

Mr. Meacham moved approval up to \$2.6 million in bond financing for the School of Science and Mathematics as authorized by 73 O.S. §168.3, including distribution of requests for proposals, review by the same screening committee used in previous bond financings, and other action deemed necessary by the Authority Secretary, subject to final action by the Authority. Mr. Hendrick seconded the motion. Motion carried with the following votes: Lt. Governor Askins, yes; Mr. Meacham, yes; Mr. Hendrick, yes; Mr. Richard, yes; Mr. Ridley, yes; Mr. Watkins, yes; and Governor Henry, yes.

<u>Agenda Item 4</u> – Discussion and possible authorization for the Authority Secretary to acquire a parcel of land by any lawful method in connection with the Lincoln Renaissance project and to take other action deemed reasonably necessary by the Secretary, all subject to availability of funds.
