VI. Committee Business

Committee

- **Compressor Operator-Level One test, standards, skill assessment and certification** process were reviewed and discussed. Danny Ware, FTVC was present to answer questions. He presented the final versions of the test created with the assistance of industry leaders and in conjunction with the curriculum created under the guidance of OSU-Okmulgee. This process will be used in the certification course for compressor operators-Level One.
 1. **The certification process** was reviewed and discussed. Charles Lawson made the motion to accept the certification process. Roger Luke seconded the motion. Motion passed 4-0. John Cook left the meeting at 10:35am and requested Charles Lawson act as Chair for the remainder of the meeting.
 2. **Skill Assessment Standards** were reviewed and discussed. Craiton Cooper made the motion to accept the standards as presented. Charles Lawson seconded the motion. Motion passed 4-0.
 3. **Test** was reviewed and discussed. Charles Lawson made the motion to accept the test as presented and update the test as updates in technology and NFPA 52 deemed necessary. Craiton Cooper seconded the motion. Motion passed 4-0.

- **LPG**
 1. **Skill Assessment Standards** were reviewed and discussed. Paula Cowart, Director of Safety, Training, & Ed of OK LP Gas Research, Mktg, & Safety Commission was present and answered Committee questions. Craiton Cooper made a motion to approve the LPGas Skill Assessment Standards as presented. Charles Lawson seconded the motion. Motion passed 4-0.
 2. **LPG Skill Assessments** – were reviewed and discussed. LPG Defueling Exam; Fuel Line/Hose Assembly Exam, LPG System Inspection Exam and LPG Vehicle Inspection Exam were approved without changes. The Committee required the LPG Cylinder Inspection Exam to be updated to remove the 4th item Surface Discoloration and Cracking to be removed and 7th line to correct the misspelling of the word ‘bubles’ to ‘bubbles’. Motion made to approved the skill assessment exams by Charles Lawson. Craiton Cooper seconded the motion. Motion passed 4-0.

- **NFPA -52 Changes and update of two test versions** – Postponed until September meeting. The Committee requested time to review the changes in NFPA 52 and review the tests to determine what questions on the two versions needed to be updated. Also, Craiton Cooper recommended adding more questions to the compressed natural gas test to ensure certification validation of certified technicians be certified to also conduct tank/fuel system inspections.
