Agenda Item 1 – **Determination of quorum and call to order.** [Trait Thompson]

- Update on Allan Houser at the Capitol: A Legacy in Bronze.

Mr. Stone made known to the commission the exhibition sculptures on the east, north and west side of the Capitol will be removed on April 23-24 with the assistance of Manhattan Construction Company, using Allan Houser Inc. and Tony Lee.

On behalf of the commission, Chairman Thompson expressed his gratitude for the time the exhibition was displayed on the Capitol grounds to the Oklahoma Arts Council, the Friends of the Mansion and the Kerr Foundation for funding, and to Manhattan Construction for their assistance.

- Governor's Mansion: Temporary relocation of artwork during remediation.

Due to the necessary deferred maintenance, regarding the works on the first floor that the commission oversees, Mr. Stone is working with the Oklahoma History Center to have the works removed and anticipates the removal will be in the last week of May or the first week of June.

Mr. Stone also informed when the time comes for the works to be returned to the first floor of the mansion, this item will come back before the commission regarding placement in the fall.

- Capitol Restoration Project Update:

Chairman Thompson is pleased with how the exterior and interior of both projects has accelerated over the past couple of weeks. Trial repairs will be starting in the next six weeks.

Mr. Mass gave an overview to the commission of what trial repairs to the exterior and interior of the Capitol entail.

Chairman Thompson said this project is to be done in a methodical way so that it's done carefully. The methods and materials being used are going to last many years.
