Successful Bidder Verification with the Secretary of State

A. Initial information about bidder's status is gathered through DCS-FORM-CP-076, Responding Bidder Information:

Registration with the Oklahoma Secretary of State:

- ☐ NO - Prior to the contract award, the successful bidder will be required to register with the Secretary of State or must attach a signed statement that provides specific details supporting the exemption the supplier is claiming (<http://www.sos.ok.gov> or 405-521-3911).

B. If the contract amount is Twenty-five Thousand Dollars (\$25,000.00) or greater, compliance with 74 O.S. § 85.5(N) must be accomplished by conducting the following procedure:

2. Add this link to the Internet browser's favorites or save it as a link on the desktop of PC for future easy access
3. Click on tab "Business Services", then "Business Entities", then "Records / Search"



4. Click on "online search feature"



5. Click "Advanced Search"

7. Click on "Filing Number"

- 7.1. Finding a business name under "Search Active" does not constitute compliance with the law. "Inactive", "Ousted", "Revoked", "Dissolved" and "Expired" business entities remain in the "Search Active" records for three years from the date of status change. Complete the verification in full.
- 7.2. Contracts are awarded using the legal name of a business entity. If the supplier name searched appears as a "tradename" or a "former" name, the legal name of the business will appear at the top of the screen upon selecting the "Filing Number" (see #8).
