Ms. Ballard suggested the vendors suggest or recommend shipping with their fair market prices and this be presented for approval by the Committee. Vendors could email their ideas to Larry Smith. Mr. Oliver suggests any vendor losing money because of shipping should request new fair market pricing.

Judy Goodwin from Oklahoma Community-Based Services notified vendors of a speaker on April 14. Senate Bill 176 and state budgets were discussed briefly. Mr. Ross briefly discussed several bills that will affect State Use. One consolidates the Department of Central Services and moves them under the Office of State Finance. Another piece of legislation requires any organization that must register would be moved to the Department of Commerce for one stop licensing. HB 1208 allows the Governor to appoint all board members to all boards and commissions in the State of Oklahoma.
