This is the first increase in 3 years and reflects the higher cost of providing service to the more technicallycomplicated Tier 4 Diesel Emissions compliant equipment. The new equipment requires more specialized and more costly diagnostic equipment. Additionally it requires that service techicians receive further sprcialized training.
