THIS ADMENDMENT is by and between the State of Oklahoma (Participating State), and EMC Corporation (Contractor).

WHEREAS, the Lead State has a Contract with the Contractor identified as Number B27161, effective September 1, 2009 thru December 31, 2014, to provide direct-from-manufacturer personal computer equipment and related devices, software, and services; and
