GlobalCerts email encryption appliances have been set as the state standard for e-mail encryption

SMG2i Appliance-

Training

The initial training for Administrator and Users is included as part of the installation. Up to 3 hours of training is part of the set up and installation of the SecureMail Gateway solution. Addition training can be arranged, if required, following proper procurement procedures.

Fixed Annual Price of \$50,000 for up to 1 00,000

Price for additional user: \$1 per user per year.

Support is provided as long as the hardware requirements outlined by GlobalCerts are available to the Virtual SMG2i. Minimum requirements per system are:

4vCPU (X5660 @ 2.80GHz), 8GB memory, and 225GB high performance drive
