This Addendum 1 ("Addendum") is an Amendment to the Contract awarded to O'Reilly Automotive Stores Inc. by the State of Oklahoma in connection with Solicitation 0900006747 ("Solicitation") and is effective on the date of the last signature below.

**Recitals**

Whereas, the State issued a Solicitation for proposals to provide Immediate Need Aftermarket Automotive Parts, as more particularly described in the Solicitation;

Whereas, O'Reilly Automotive Stores Inc. submitted a proposal to the Solicitation and was awarded the Contract in connection with Solicitation 0900006747; and

Whereas, the Contract resulting from Solicitation No. 0900006747 prohibits Contractor from assigning its rights or delegating its responsibilities, in whole or in part, without the prior approval of the State of Oklahoma; and

Whereas, O'Reilly Automotive Stores Inc. ("Stores") is assigning certain rights and responsibilities under the Contract resulting from Solicitation No. 0900006747 to O'Reilly Auto Enterprises LLC ("Enterprises").

Now, therefore, in consideration of the foregoing and the mutual promises set forth herein, the receipt and sufficiency of which are hereby acknowledged the parties agree as follows:

1. **Addendum Purpose.**

This Addendum memorializes the assignment of certain rights and responsibilities under the Contract resulting from Solicitation No. 0900006747 by O'Reilly Automotive Stores Inc. to O'Reilly Auto Enterprises LLC. This Addendum memorializes the State of Oklahoma approval of such assignment as required by the Contract resulting from Solicitation 0900006747.

2. **Assignment of Certain Rights and Responsibilities under Contract**

Stores assigns certain rights and responsibilities under the Contract resulting from Solicitation No. 0900006747 to Enterprises. Stores assigns to Enterprises all right, title, interest, and obligations granted to or required of Stores under the Contract resulting from Solicitation No 090000674 to Enterprises with respect to the Participating Entities and local governmental agencies in the following states:

State of Oklahoma approves of the assignment by Stores to Enterprises.


4. Miscellaneous

PARTIAL ASSIGNMENT OF MASTER PRICE AGREEMENT

This Partial Assignment of Master Price Agreement (the "Assignment") is made and entered into this 5<sup>th</sup> day of October, 2016, by and between O'Reilly Automotive Stores, Inc., a Missouri corporation ("Stores") and O'Reilly Auto Enterprises, LLC, a Delaware limited liability company ("Enterprises").

WHEREAS, Stores entered into that certain Master Price Agreement (the "Master Agreement") dated July 20, 2016, with the State of Oklahoma; and

WHEREAS, Stores and Enterprises are affiliated entities, and Stores desires to assign a part of its rights and obligations under the Master Agreement to Enterprises.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by the parties hereto, Stores and Enterprises hereby agree as follows:

1. Stores hereby assigns to Enterprises, and Enterprises hereby accepts from Stores, the assignment of Stores' right, title, interest, and obligations granted to or required of Stores under the Master Agreement with respect to the following states: Alaska, Arizona, California, Colorado, Hawaii, Idaho, Illinois, Kansas, Massachusetts, Maine, Michigan, Minnesota, Montana, North Dakota, Nebraska, New Hampshire, New York, Nevada, Ohio, Oregon, Rhode Island, South Dakota, Texas, Utah, Vermont, Washington, West Virginia, and Wyoming.

2. Enterprises will fulfill all of Stores' obligations under the Master Agreement and will be the contracting party to any agreement signed with any purchasing entity in the states listed above. Enterprises will receive all the benefits of Stores arising under the Master Agreement with respect to any such agreements.
