Oklahoma City, OK 73105 - **Description of Amendment:**

Please Note: The questions and answers pertain to the DOC facility listed in the solicitation. This contract will cover all Authorized Users in the State of Oklahoma; so, the amounts, etc. may change. We don't have any data at this time for any Authorized User other than the DOC facility listed.

Questions and Answers

Question: What is the average number of meals needed for the DOC facility listed in the solicitation? How many Kosher versus general specialty?

Answer: Halal meals is =10,800 per a year. Kosher meals = 153.600 per year. Passover meals = 6,000 per a year. Food varieties that are approved for either Kosher or Halal = 83,400 per year.

Question: Are the other specialty meals like diabetic, gluten free etc.? Answer: Yes.

Question: How often is delivery needed? Answer: One or two times a month.

Question: Will you need breakfast, lunch, and dinner? Answer: Yes.

Question: Would we need it to be Kosher Paurve? Kosher Dairy? Answer: No.
Question: Would it need a Mashgiach supervision or what kind of proof needed that it's Kosher? Answer: Yes, a certification from the Muslim /Islamic / Jewish council to show that the meals are prepared under the certified strict guideline for Halal and Kosher.
Question: What proof of Halal certification would you need? Answer: Halal would be IFANCA PRODUCT CERTIFICATE and Kosher would be KASHRUTH CERTIFICATION.
