Description of Amendment:

a. This is to incorporate the following:

Below are the questions and answers for this solicitation. Deletions are noted with a strikethrough, additions are noted by an underline.

Q1) I noticed there was no mention of a baler on this RFP. Has this been purposely removed from the RFP?

A1) The facility does not have a baler and does not need one.

Q2) The time allowed between Response Due Date and the Effective Date of the purchase order is only 2 weeks. This does not allow enough time to order compactors, have shipped, and install LOCKABLE doghouse before the requested date to set equipment at the facility. We would need a minimum of 30 days from receipt of purchase order to accomplish this and install at each facility. This will be all new equipment.

A2) The contract period has been revised.

B.3. Contract Period

B.3.1. Contract period is ~~August~~ September 1, 2017 through ~~July~~ August 31, 2018.

B.3.2. The provision in this contract shall include four (4) options to renew, each for the duration of one (1) year, at the discretion of the Department of Corrections based upon continuing need and Supplier performance.

B.3.3. The renewal(s) will begin on ~~August~~ September 1st of each year and run through ~~July~~ August 31st of the following year.
