**ANSWER #3** – Samples are not requested, per Section E.6.1 - Technical documentation (brochures/specifications) is required by this RFP.

**QUESTION #4 - Page 10, B12.1 Minimum order requirements:**

- a. **Does this apply to orders from State Department, Boards, Commissions, Agencies and Institutions only?**
- b. **Does this apply to \$ minimum, quantity minimum or both?**
