**Description of Amendment:**

a. This is to incorporate the following:

- Q.1 Clarification of what the solicitation is for.
  - A.1 Construction Equipment listed on Schedules A, B, C, D, E and F. (To clarify, Attachment D, Telehandler, Material Handers does include Articulated Dump Trucks.) The rest are clearly defined.
- Q.2 Will mini skid steers be considered?
  - A.2 Yes. The solicitation is for both compact and full size construction equipment.
- Q.3 Will you change the wording in C.9.4 to match the formula for trade-ins.
  - A.3 Yes, the wording for C.9.4 should be "Any trade-in allowances determined by the dealer shall be deducted from the established current price **after** the discount is applied. The formula will be to deduct the discount from the established current price and then take off the trade-in allowance." The formula given as an example is correct.
- Q.4 The solicitation appears to cover all construction equipment, big and small.
  - A.4. Yes it does.
- Q.5. What will happen to the equipment a present vendor already has on SW190, the contract that is being split up into smaller contracts?
  - A.5. Equipment that is already on SW190, is going to be taken off of SW190 after the award of SW192. You do have to bid on SW192 in order to get your equipment on the new contract, the equipment won't just be moved over without an award made from SW192.
- Q.6. Do you know when this will be awarded?
  - A.6. As soon as possible after the solicitation closes, within two weeks from May 22, 2014.

**Description of Amendment - continuing**

Q.7. Are you going to be bidding out tractors and brush chippers?  
A.7. Yes. Presently the State of Oklahoma has one contract for many types of equipment. SW190 is too cumbersome, so it is getting split into several smaller contracts. The solicitations are going to be coming out in May, 2014. There will be a contract for the Mowers and outdoor hand held equipment (blowers and chain saws, etc), one for Agriculture Tractors, Implements, Brush and Tree cutting equipment and trailers, this one, for Construction equipment, one for Trash Trucks, Road maintenance, Golf Carts and Utility Vehicles. Vendors please be aware that you will be getting notices when these solicitations are placed on our web site.  
Q.8. The solicitation has language concerning allowable charges that are not on presently on SW190.  
A.8. Please refer to C.17.3 and C.17.4. The terms were included in the original SW190 solicitation.  
Q.9. We seem to be missing "Solicitation Package – Page 4" from the SW192 request. Goes from Page 3 to Page 5.  
A.9. There are no missing pages. I was unable to get the pages to number correctly.  
Q.10. What about other equipment sold by dealers, such as tractors?  
A.10. There will be vendors who will have more than one contract. Splitting up the contracts into smaller ones is to make it easier for customers to find what they need on our website.  
Q.11. Will the closing date be changed?  
A.11. Yes. The new closing date will be May 22, 2014 @ 3:00 pm. Please make sure you have your response in Central Purchasing's office by that date and time or your response will not be considered.
