Q7. In Item G Price and Cost: Are we to provide all of the items referenced in C.3.1.1. in this space? If yes, providing a fixed price for a pole is problematic, as freight is the largest variable in the pricing of a pole for a customer. That cost could vary dramatically depending on quantity and distance as this is a statewide contract.

Would consideration be given to fixed pole price included in C.3.1.1 with the exception of the freight being added to each customer on a pre-pay and add basis with the freight quote/invoice provided to each customer from the pole manufacturer?

A7. The State is seeking bid responses for turn-key outdoor warning systems. Bidders are required to provide the basic system requirements as defined in C.3.1. Freight charges can be bid as a separate line item. Pursuant to A.13.1., the supplier shall prepay all packaging, handling, shipping and delivery charges and prices quoted shall include all such charges.

Q8. Can you advise if it is still open? If so, have there been any posted addendums?

A8. The solicitation is still open with no addendums posted.
