**ADDENDUM 1 TO
STATE OF OKLAHOMA CONTRACT WITH

This Addendum 1 (“Addendum”) is an Amendment to the Contract awarded to Lakeshore Equipment Company (“Supplier”) in connection with Solicitation 0900000350 (“Solicitation”) and is effective February 12, 2019.

Recitals

Whereas, the State issued a Solicitation for proposals for Science, Technology, Engineering and Math (STEM) Educational Tools and Products for use by all Oklahoma educational entities; and

Whereas, the State and Supplier have negotiated the final terms under which Supplier will perform the Services under the Contract.

Now, therefore, in consideration of the foregoing and the mutual promises set forth herein, the receipt and sufficiency of which are hereby acknowledged the parties agree as follows:

1. Addendum Purpose.

This Addendum memorializes the agreement of the parties with respect to negotiated terms of the Contract that is being awarded to Supplier as of even date with execution of this Addendum. The parties agree that Supplier has not yet begun performance of work contemplated by the Solicitation.


2. Negotiated Documents of the Contract.

2.1. The parties have negotiated certain terms of the Contract as follows:

- i. certain negotiated exceptions as contained in Attachment A to this Addendum; and
- ii. confirmation that any pricing increase during a given term shall not exceed the lower of either 2% or the current CPI, provided that pricing may be renegotiated during a subsequent renewal term.

- 2.2. Accordingly, any reference to a Contract Document refers to such Contract Document as it may have been amended. If and to the extent any provision is in multiple documents and addresses the same or substantially the same subject matter but does not create an actual conflict, the more recent provision is deemed to supersede earlier versions.

Negotiated Exceptions to the Solicitation

The Solicitation is hereby amended as set forth below and supersedes all prior Exceptions submitted by Supplier or discussed by the parties.

RFP Section	Exception
A. General Provisions, A.13 Delivery, Inspection and Acceptance	A. General Provisions, A.13.1 Delivery, Inspection and Acceptance Second sentence is hereby deleted in its entirety and replaced with the following: A.13.1 The Supplier shall prepay all packaging, handling, shipping and delivery charges and price quote shall include all such charges, provided that for orders under \$250.00, freight charges shall be assessed at an estimated 15% of sub-total, with a minimum freight charge of \$5.00.
