Description of Amendment:

a. This is to incorporate the following:

- Q.1 Paragraph C.3.1.4 and C.3.2.4: When is the Governor available to approve fabric color and/or type? This may have an impact on delivery date.
- A.1 Expediency is of utmost importance to the Governor’s office, and availability will be worked out upon award.
- Q.2 Paragraph C.3.2.1 references ‘CR Laine – Gotham Armchair’, yet the picture attached is of ‘CR Lain “Hans Chair”’. Please clarify which chair is required.
- A.2 CR Laine – Gotham Armchair is required. Picture attached below.
- Q.3 Paragraph C.3.7, Assortment of Accessories: Please provide specific information on each of the 4-line items required.
- A.3 Agency has declined to provide more specific information. This is a “lowest and best” evaluation and C.3.7.1 – C.3.7.3 are specific names and sizes of existing products. Item C.3.7.4 is for decorative pieces and should conform to the brand specified: Assouline.
- Q.4 Paragraph F.1.7 states ‘Proof of Liability and Worker’s Compensation Insurance’ is to be returned with the response. Why is this required if we are having items delivered only?
- A.4 The delivery shall be completed on State property. Bidders taking exception to this requirement shall indicate this in the bid and provide documentation of exemption or non-applicability to this requirement.
- Q.5 Attachment A-1: Can the offeror add a line to state which piece of furniture the Attachment is referring to?
- A.5 Attachment A-1 has been amended to reflect lines for each piece of furniture. Pricing is to include freight or shipping charges and any applicable administrative fees.

Q.6 Regarding the Oushak Rugs sized 8'x10' & 9'x12'. Is there a particular rug # that should be priced by all bidders?

A.6 The designer has indicated that they typically use one-of-a-kind handmade rugs for clients, so numbers for preferred rugs do not really exist. For comparison, the designer has provided the following information for acceptable styles:

7'9" x 9'9"

Vendor will work with office personnel upon award to provide specific details of that which is needed.

Q.7 Oushak has thousands of rugs and the price points vary according the specific rug. If a specific rug # is not provided shall all bidders carry the same allowance for a future procurement?
