Pricing Overview

The pricing information is broken into two sections. The first is pricing for **on-premise deployments**, which involves the initial purchase of perpetual-use software licenses and professional services for installation and training, followed by fees for ongoing annual maintenance and support.

The second section details pricing for cloud-based, or **hosted deployments** which primarily involve the initial costs for installation and training, followed by flat per named user subscription fee that covers use of the software (includes all modules), hosting infrastructure, maintenance, and support.

On-premise Deployment Pricing

ACISS Systems offers a few key licensing benefits for large organizations that require multiple on-premise deployments of ACISS software.

First, ACISS software module licenses allow unlimited deployments within a single organization. For example, once a module, like ACISS Case Management, is purchased for one system, any additional systems deployed within the organization would not require a new Case Management license to be purchased. The additional systems would only require new licenses to be purchased for any previously unlicensed modules, plus the required number of concurrent users.

Second, ACISS Systems offers volume discounts on Concurrent User License purchases. This provides discounted pricing when purchasing blocks of at least 100 concurrent user licenses. Those blocks of user licenses can then be split and distributed amongst any number of ACISS deployments within the organization. The following table outlines the current volume discount schedule.

A typical on-premise deployment would include the following costs:

- Software licenses
- Software maintenance and support
 - There is no charge during the first year, as software licenses include the first year of maintenance and support
- Hardware costs (if purchasing equipment)
- Professional services
 - Data migration costs based on complexity of data to be migrated (\$185/hour, T&M, fixed cost)
 - Custom development if new features or interfaces are required for deployment (\$185/hr fixed cost)
 - Pre-installation consulting fees, which varies based on the size and complexity of the deployment (\$1,480/day)
 - Installation fees, which varies based on the complexity of the deployment environment (\$1,480/day)
- Training, which varies based on the modules purchased and the number of users to train.

- Hardware costs (if purchasing equipment)
- Professional services
 - Data migration costs based on complexity of data to be migrated (\$185/hour, T&M, fixed cost)
 - Custom development if new features or interfaces are required for deployment (\$185/hr fixed cost)
 - Pre-installation consulting fees, which varies based on the size and complexity of the deployment (\$1,480/day)
 - Installation fees, which varies based on the complexity of the deployment environment (\$1,480/day)
- Training, which varies based on the modules purchased and the number of users to train.
