1. Exhibit Titled Price, each "Product Specifications" states "CPL Test Code...or equivalent," request clarification of "CPL Test Code."

CPL test codes are codes from Clinical Pathology Laboratories directory.
2. Exhibit Titled Price, the product specifications is absent of CPT codes for identifying tests and ease of pricing; appears the codes are specific to CPL?

CPT Codes have been added to an updated Exhibit titled Price.
3. Exhibit Titled Price, Lines 124/125, "CPL Test Code 3954 or equivalent – HIV 1 RNA, QL TMA" appears to be the same test as Line 158/159, please clarify if same test or different.

158/159 had the correct test number, however the difference was a typo. It should be HIV Nucleic Acid Amplification Test.

4. Exhibit Titled Price, Lines 26/27, "CPL Test Code 18841 or equivalent – Ferritin and Iron," appears to be a Laboratory Developed Test or is it the same as Lines 164/165, "CPL Test Code 222 or equivalent – Iron," please clarify difference between Ferritin and Iron tests.

Separated Ferritin and Iron Tests on Exhibit Titled Price. Ferritin and Iron have different testing requirements.

5. Exhibit Titled Price, Lines 160/161, "CPL Test Code 7581 or equivalent – COVID-19 Moderate Risk" and Lines 162/163 "CPL Test Code 7305 or equivalent – COVID-19 High Risk. Please provide clarification of difference between these two COVID tests.

Changes made, CPL Test Code 7581 was changed to CPT test Code 7304 – SARS-COV-2 TOTAL B. CPL Test Code 7305 remained the same however, definition changed to SARS-COV-2, NAAT.

6. Must we bid all line items?

Yes, we want one vendor to perform all or none.

7. What is expected turnaround time for test results?

Posted is the production of the previous supplier for reference as "Previous Production Schedule"

8. Can you provide a list of locations for sample pickup?

Posted in the "Sample Pickup Locations" documents

9. Who is the current vendor?

Clinical Pathology Laboratories

10. Can you provide current contract rates?

Posted is the previous supplier's previous RFP price response.
