This Addendum (“Addendum”) is an Amendment to the State Wide Contract #0138

**Purpose**

With this addendum the current contract, is modifying the language contained in Attachment A, Exhibit 1 B.7.

The language in that section currently states:

“A Supplier receiving an award letter for any well plugging project will have thirty days after receipt of the award letter to plug the subject well(s). Any costs in excess of the original estimate, must follow Section A3 as set forth above. In the event that the subject well(s) is/are not plugged within the requisite thirty (30) days, the subject well(s) will be offered to the next Supplier on the list for the related district.

The language above in that section is being modified to read:

“A Supplier receiving an award letter for any well plugging project will have sixty (60) days after receipt of the award letter to plug the subject well (s) or have a rig on site with plugging operations underway. An additional 30 days must be approved by the appropriate District Manager and requested prior to the expiration of the sixty (60) days. Any costs in excess of the original estimate, must follow Section A3 as set forth above. In the event that the subject well(s) is/are not plugged within the requisite sixty (60) days, the subject well(s) will be offered to the next Supplier on the list for the related district.
