

This First Amendment to Addendum 1 (the “First Amendment”) is made this 4th day of October 2021, between the State of Oklahoma by and through the Office of Management and Enterprise Services (“State”) and Toshiba America Business Solutions, Inc. (“Supplier”) and is a Contract Document in connection with Oklahoma Statewide Contract No. 1013 (“SW1013”) between the State and Supplier. This First Amendment supplements and amends the Addendum entered between the parties effective on August 19th, 2020, and included here as an attachment, including all supplements and amendments thereto (“SOW”) Unless otherwise indicated herein, capitalized terms used in this First Amendment without definition shall have the respective meanings specified in the SW1013. Any terms and conditions not referenced in this Amendment remain in full force and effect as agreed to by the parties.

Purpose

For good and valuable consideration, the parties agree as follows:

1. This Amendment amends the language of the SW1013 Contract between the State and Supplier to reflect distinction between purchases and leases made through Supplier’s reseller, J.D. Young. Specifically, State agencies issuing a Purchase Order must utilize the following updated ordering information:
 - a. For Leases, use identifier #002 to reflect J.D. Young’s performance of Supplier obligations with remit of payment addressed to Wells Fargo;
 - b. For Purchases, use identifier #003 to reflect J.D. Young’s performance of Supplier obligations with remit of payment addressed to J.D. Young.


