Description of Amendment: Answers to Bidder Questions Submitted prior to 3pm on 5/24/2022

a. This is to incorporate the following:

For Clarification, this solicitation is intended to be a mandatory, Statewide Contract, meaning that all State Departments and Affiliates can utilize this contract. Each Department would work directly with the vendor through this contract to tailor services to achieve their specific departmental goals.

1. Year to date how many drug screens have been conducted? **Answer to 1-8 below.**
2. Year to date how many alcohol tests have been conducted? **Answer to 1-8 below.**
3. Year to date how many pre-employment tests have been completed? **Answer to 1-8 below.**
4. Year to date how many post-accident tests have been completed? **Answer to 1-8 below.**
5. Year to date how many Reasonable Suspicion tests have been completed? **Answer to 1-8 below.**
6. How many random testing pools? (Example: all DOT employees are in one pool and NON DOT are in another pool, so the total number of managed pools is two.) **Answer to 1-8 below.**
7. What is the total number or participants (number of employees) in each random pool? **Answer to 1-8 below.**
8. What is the frequency of pulling random and testing? (quarterly, monthly, other?)

A. For Questions 1-8 OMES is unable to provide these statistics as those numbers would come from the departments and affiliates. Please refer to Bidder Instruction, Section 8.8.1.A for Historical Purchasing Sums. An additional Exhibit 8, a list of departments and affiliates has also been made available.

9. Will the state provide one point of contact for the vendor?
- A. Asha Parks will represent the state on any questions for the solicitation or contract and will serve as the contract manager post award. However, each department will need to provide their direct contact information when setting up services. The department will be the main point of contact regarding specified services.
10. Will the state provide a list of current employee locations to ensure clinics are established within the 50-mile radius?
- A. See additional Exhibit 8, listed are the department and affiliates across the state, each department may have any number of locations that they govern. Exact locations of all are not available currently.
11. Would the state be willing to schedule clinic tests via an online portal or will the State request the testing through the Vendor and ask the Vendor to set-up and scheduling the Clinic testing?
- A. Scheduling tests on an online portal is acceptable, however bidder would be subject to a security assessment and would need to meet the Oklahoma security standards.
12. Is a mobile unit required or will onsite testing capabilities, for the same volume listed in the RFP documents be sufficient?
- A. A mobile unit is not required.
13. Who is the current drug and alcohol testing provider?

14. Why is the State looking for a new provider?
- A. The Current Contract Period ends 6/24/2022. By state statute a solicitation must be conducted at a contracts end. This helps to promote better pricing and value for the state.
15. Can you please confirm the number of DOT employees potentially covered under this contract as well as the number of DOT drug screens performed annually? See Answer to Question 15-16 below.
16. Can you please confirm the number of Non-DOT employees potentially covered under this contract as well as the number of Non-DOT drug screens performed annually?
- A. For Questions 15-16 OMES is unable to provide these statistics as those numbers would come from the departments and affiliates. Please refer to Bidder Instruction, Section 8.8.1.A for Historical Purchasing Sums. An additional Exhibit 8, a list of departments and affiliates has also been made available.
17. Can you please provide the total number of potential Using Entities covered under this contract?
- A. See additional Exhibit 8, listed are the department and affiliates across the state, each department may have any number of locations they govern.
18. Can you please summarize the geographic location of the Using Entities/Employees covered under this contract?
- a. The goal here would be to identify the density of employees in areas outside of major metropolitan areas. A generic response such as "75% of covered employees are located in OKC or Tulsa" for example would sufficiently answer my question I believe.
- A. Note in addition to Exhibit 8, all Local government agencies such as city or county departments are also considered affiliates, there are numerous agencies across the state of Oklahoma. All of which can utilize this contract. OMES is not able to provide the potential percentage of coverage.
