- January 1, 2023- Clean Harbors; 10%-30% disposal fee
- January 3, 2023- Tradebe; 7.5% - 12% disposal, 12% transportation

The following invoicing adjustments will become effective June 1, 2022, or when contractually allowed:

1. Current Energy Insurance & Security Surcharge (EIS) will increase by 3%.  
This fee applies to disposal services only.
2. Disposal rates will increase by 8%.  
Some specific waste categories will have a different increase. If your associated generator number is listed below, please feel free to discuss with your Heritage sales representative or view in EIS.
3. Transportation rates, fees, items, and rental will increase by 12%.
4. Due to the capacity constraints on transportation assets nationally, Heritage is updating its quoted Terms & Conditions on its freight cancellation policy to increase optimized efficiencies and capacity levels.

6.5 Freight Cancellation and No Load.

Customer will be responsible to pay full LTL/FTL quoted freight charges when either:

- a. Order is cancelled within 24 hours of scheduled pickup date/time.
- b. Materials scheduled for transportation are not available at Customer site upon Company arrival (No Load).

6.6 Freight Late Notification Cancellation.

Customer will be responsible to pay \$1,500 per event when either:

- a. Order is canceled within 48 hours of scheduled pickup date/time.
- b. Driver assigned by Company for scheduled pickup is in transit to Customer site when order is canceled.

US Ecology, Inc. remains committed to providing the highest quality environmental and industrial services in a safe and compliant manner.

During the past several months, we have initiated various cost control initiatives to deal with inflationary pressure and implemented some moderate price increases. However, we continue to experience escalating costs well beyond prior expectations and the impacts are on many items used in our daily business, including treatment reagents, supplies, equipment, labor, energy and insurance.

To maintain our high level of customer care while providing your company with a wide range of waste management solutions, we must now pass along a portion of these increased operating costs. This letter is to notify you that effective September 1, 2022, an additional 10% will be added to all treatment and disposal pricing, and an additional 2.0% will be added to our Energy, Insurance and Recovery (EIR) fee. The EIR fee will continue to appear on your invoices as a separate line item assessed on treatment and disposal charges.


Increases will be rounded up to the nearest \$0.25 increment for containerized and bulk waste and to the nearest \$0.01 increment for all materials billed as per lb. and/or per gal. This increase will not apply to new profiles and pricing schedules established June 3, 2022 to August 31, 2022.

Our management team has been analyzing current challenges and forecasting inflationary impacts affecting our operations, most not seen for decades. At this time, we must increase our EIS surcharge due to significant escalation in related supply chain costs.

Effective October 15th, 2022, or as allowed by contracted terms, our EIS rate will be increased by 10%. Currently, all other price points remain the same. As we have done before, when these challenges have stabilized and the inflationary rate returns to normal, we will work to reduce the EIS rate.

Tradebe appreciates your business as a valued customer. As always, we are here to assist with your environmental needs and to help you achieve your sustainability goals.

As you have undoubtedly seen, unsettling world events and macroeconomic changes continue to put sustained pressure on costs for many suppliers of materials and services. Tradebe is committed to mitigating the impact of these changes on our customers. However, we have seen unprecedented and dramatic increases in our costs across the board. These include not just rising inflation but also higher equipment and material prices, a spike in energy costs, and increases in almost all other cost components of the business. Unfortunately, not all of these impacts can be absorbed.

As a result of these unprecedented cost impacts, Tradebe will be increasing certain of its services fees. Effective **November 1, 2022**, as allowed per contract, our Environmental Assessment Fee (EAF) and Facility Retention Fee (FRF) are being revised as follows:

- The Environmental Assessment Fee (EAF) is being increased to **12%**. (This fee continues to apply to all lines on the invoice except transportation, other fees, and taxes.)
- The Facility Retention Fee (FRF) is being redesignated as the Labor, Supply and Energy fee (LSE), and will include supply and rising energy costs at our facilities. This fee will now appear on invoices as the **LSE** (Labor, Supply and Energy fee). The LSE will be **10%**. (The LSE continues to apply all to all lines on the invoice except transportation, other fees, and taxes.)

Tradebe appreciates your understanding through these very challenging economic times. We pledge to continue to work with you to offer the best service alternatives to meet your environmental goals.

Tradebe appreciates your business and your continued trust in our services. We are deeply committed to assist with your environmental needs and to help you achieve your sustainability goals.

The economic context along with unprecedented industry constraints continue to put sustained pressure on costs for many goods and services impacting our business. National inflation rates have been at historic highs during the year and remain a challenge as we look forward into 2023. Additionally, we have recently seen increased restrictions and costs in disposal outlets. In this turmoil, Tradebe has been dedicated to find efficiencies to absorb these cost impacts, to protect the quality of our service and our commitment to safety and compliance, and to raise our internal capabilities.

Despite all efforts, we are forced to review our base rates to partly cover these significant cost changes. After much consideration, **effective February 1, 2023**, the following price changes will be applied to all existing profile approvals and price schedules for waste shipped into our Tradebe facility network:

- **Disposal** of containerized material for all treatment technologies will be increased by 12%,
- **Disposal** of bulk material for all treatment technologies will be increased by 7.5%,
- **Transportation and all other services** will be increased by 12%.

Additionally, due to the prolonged uncertainty in the market, disposal rates for incineration or other disposal technologies with high capacity restrictions will continue to be determined case by case. This affects the following process codes:
