

**STATE OF OKLAHOMA STATEWIDE CONTRACT WITH HALL  
MANUFACTURING, LLC**

This State of Oklahoma Statewide Contract (“Contract”) is entered into between the state of Oklahoma by and through the Office of Management and Enterprise Services and Hall Manufacturing, LLC (“Supplier”) and is effective as of the last signature date, with two one-year options to renew this contract.

**Purpose**

The State is awarding this Contract to Supplier for the provision of providing repair services and parts for non-highway, farm, and heavy construction equipment owned by Authorized Users within Oklahoma. Supplier submitted a proposal which contained no exceptions to the Solicitation. This Contract memorializes the agreement of the parties with respect to terms of the Contract that is being awarded to Supplier.

Now, therefore, in consideration of the foregoing and the mutual promises set forth herein, the receipt and sufficiency of which are hereby acknowledged the parties agree as follows:

1. The parties agree that Supplier has not yet begun performance of work under this Contract. Upon full execution of this Contract, Supplier may begin work. Issuance of a purchase order is required prior to payment to a Supplier.
