



STATE OF OKLAHOMA STATEWIDE CONTRACT WITH GALLS, LLC

This State of Oklahoma Statewide Contract (“Contract”) is entered into between the state of Oklahoma by and through the Office of Management and Enterprise Services and Galls, LLC. (“Supplier”) and is effective as of the date of last signature to this Contract through June 25, 2024.

Purpose
