**STATE OF OKLAHOMA THIRD ADDENDUM TO STATEWIDE CONTRACT 1031
WITH USIC LOCATING SERVICES, LLC.**

This Third Addendum (the “Addendum”) to Statewide Contract SW1031 (the “Agreement”) is effective on the date of the last signature below (the “Effective Date”) and is entered into by and between the State of Oklahoma by and through the Office of Management and Enterprise Services (the “State”) and USIC Locating Services, LLC. (the “Supplier”) each a “Party” and collectively, the “Parties.”. Unless otherwise indicated, capitalized terms used in this Addendum without definition shall have the respective meanings specified in the Agreement.

RECITALS

WHEREAS, Supplier and State entered into the State of Oklahoma Statewide Contract with USIC Locating Services LLC, on November 29, 2021 (the “Agreement”) pursuant to which Supplier provides the labor and equipment necessary to provide Locate Services relative to Locating and Marking of State’s Facilities; and

WHEREAS, the Parties wish to amend Agreement , specifically pricing proposals thereof, which provide pricing for Supplier’s Locate Services, to reflect an increase in price as set forth herein.

NOW, THEREFORE, in consideration of the mutual covenants, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties, intending to be legally bound, hereby agree to amend the terms and conditions of the Agreement as follows:

1. Effective as of the Addendum Effective Date, this Addendum supplements and amends the Agreement.
2. On or after the Effective Date, “2022 USIC Pricing” shall be deleted in its entirety and replaced with “2024 USIC Pricing”, attached hereto and incorporated herein.
3. As of the Effective Date, this this Addendum shall be for all purposes in full force and effect and part of the Agreement.
4. Except as expressly provided and set forth herein, nothing in this Addendum amends, modifies or supplements the terms and conditions of the Agreement, which shall remain unchanged and in full force and effect unless otherwise terminated in accordance with the terms and conditions of the

Agreement. This Addendum together with the Agreement (and any schedules, exhibits, attachments or supplements thereto) constitute the entire agreement between the Parties as to the subject matter of the Agreement and as referenced herein. In the event of a conflict between the terms and conditions hereof and the terms and conditions of the Agreement, the specific terms set forth in this Addendum shall govern the subject matter herein.

5. Each Party represents to the other that the person signing on its behalf has the legal right and authority to execute, enter into, and bind such Party to the commitments and obligations set forth herein.
6. This Addendum may be executed by electronic signature in counterparts (e-mail, facsimile or otherwise). The counterparts each of which shall constitute an original, but all of which together shall constitute one and the same instrument.

Pricing Definitions

Per One Call Ticket – All tickets received from State One Call.

Watch & Protect – *This is an optional service and Not Required.* If State of Oklahoma Fiber requests that a USIC technician to be onsite to ensure the protection of the utility during excavation, the fee will be billed per quarter hour once technician is on site and performing the Watch & Protect

After Hour Emergency Ticket – Any After Hour Emergency Tickets that is received between the hours 5:00 P.M - 7:00 A.M, Monday – Friday, all day Saturday & Sunday including Holidays. This fee is a flat fee and no hourly fees will be charged.
