Who is CCOG / Equalis

CCOG is a Council of Governments formed under Chapter 167 of the Ohio Revised Code and serves as a lead agency (a “Lead Public Agency”) for Equalis Group (“Equalis Group”), a national cooperative purchasing organization, by publicly procuring Master Agreements for products and services to be made available to current and prospective Equalis Group members (“Equalis Group Member” or “Member”). Equalis is the third-party procurement administrator for and duly authorized agent of CCOG, and in that role manages the procurement, contract management, marketing, sales, reporting, and financial activities of, for, and on behalf of CCOG at the direction and with the authorization of the CCOG Board of Directors

Who Qualifies to Use this Contract?

To the extent that the laws of a state, region, territory, and/or country permit, any public sector entity may join Equalis Group as a Member. The term “Public Sector Entities” includes, but is not limited to, political subdivisions, municipal corporations, counties, townships, villages, school districts, special districts, public institutions of higher education or training, units of government, state/regional/territorial agencies, state/regional/territorial governments, federal/national agencies, federal/national governments, and other entities receiving financial support from tax monies and/or public funds. Any organization that is exempt from federal income tax under Section 501(c)(3) of the IRS Code, and any other entity if permitted under the IRS Code and other applicable law, including for-profit companies, may also join Equalis.

Instructions for Use:

1. Quote and Award must include Contract# SW0070 , Facility Name & Location
2. Quote and Award may be Issued direct to Allseating OR to an approved Allseating Dealer. When a quote/ PO is being issued to a dealer the dealer must be an open authorized Allseating dealer and must be in good credit standing at time of order acceptance.
3. When PO is issued direct to dealer a copy of the STATE OK customer PO must accompany dealer order for reporting purposes.
4. Installation must be shown as a separate line item. Installation will be reimbursed on direct sell orders when payment is received. Installation is quoted on a per order basis – no limitations
