**STATE OF OKLAHOMA AMENDMENT NO. 1 TO STATEWIDE CONTRACT WITH
SIDEJOB (NKA TRUSTARR STAFFING CORP.)**

This First Amendment to Statewide 1025 - IT STAFF Augmentation with SideJob Inc. (the “First Amendment”) is effective as of the date of the last signature below, between the State of Oklahoma by and through the Office of Management and Enterprise Services and SideJob Inc. n/k/a TruStar Staffing Corp. (“Supplier”). This First Amendment supplements and amends Statewide 1025 - IT STAFF Augmentation with SideJob, Inc. entered into by the parties and effective April 2, 2024, including all supplements and amendments thereto. Unless otherwise indicated herein, capitalized terms used in this Amendment without definition shall have the respective meanings specified in the Contract.

For good and valuable consideration, the parties agree to amend the Contract as follows:

1. Due to a name change filed by the Supplier with the Secretary of State of Oklahoma on June 20, 2025, the Contract and all references within the Contract to SideJob Inc. shall be deemed to now refer to the Supplier’s new name, TruStar Staffing Corp, as of the Effective Date of this Amendment.
2. In the event of a conflict between the terms and conditions hereof and the terms and conditions of the Contract, the specific terms set forth in this Amendment shall govern the subject matter herein.
3. Except as expressly modified in this Amendment, all terms and/or provisions of the Contract not addressed herein remain as executed by the parties in the Contract and remain in full force and effect.
4. This Amendment may be executed by electronic signature in counterparts (e-mail, facsimile or otherwise). The counterparts each of which shall constitute an original, but all of which together shall constitute one and the same instrument.
